Veteran entertainment includes participation in Memorial Day activities (parades and flag placements on graves), July 4th, and Veteran's Day activities. Additionally, the Clark County Fair has a veteran day in which participants from the Post promote the Armed Forces and their history. The remembrance of our deceased veterans is vital to our country's history, so the VFW marks veteran graves with U.S. flags and provides flags for veteran coffins upon their death. Should the family of a deceased veteran desire military honors at the veteran's funeral, the Post does the honors.
