## FISH Fairborn Annual Report for 2013

Dear Friends and Supporters,

We are extremely grateful for the financial and volunteer support you gave FISH during 2013. The donated money enabled us to give financial aid for 426 needs—averaging \$35--\$50 per call for utility disconnections, evictions, and emergency lodging. Food was purchased with additional funds to supplement supplies from the Emergency Food Bank—\$39,327.86 of food items— and local food donations equaling \$45,578.90 in food items. At our pantry, we provided 4700 orders of food which fed 16,114 people—5840 children and 10,274 adults. To put this into a monthly prospective for the pantry, we are serving about 392 families per month and spending about \$3,233 per month on food to supplement the food items from the Food Bank and the donated food from the community.

Our phone workers arranged for services provided by volunteers, set up financial aid, and answered 1011 requests for information and referrals. They answered a total of 1,804 phone calls. Our total number of combined phone calls and pantry services was 6,504.

The disbursement detail from our treasurer's report on the reverse side of this letter shows how we used the monies we received from your contributions in 2013. God has blessed us this past year with a wonderful, caring community that helped us meet both goals of helping with financial aid and distributing food. We always go into the year with a carryover from past years mostly due to a large amount of Christmas donations.

I can proudly report that in 2013, 97% of our disbursements went directly to client assistance. We are able to get along with low operational costs for several reasons: we have no office; our phone workers work from their own homes; pantry space is provided by the Food Bank and the office staff prints our newsletters—we are starting to e-mail our newsletter to reduce the cost of postage. Our workers, all volunteers, pay for all of their own expenses and some donate financially. We have two major costs. We are renting a box truck (\$1,141.93) to go to Dayton to transport our government commodities from the Food Bank and we pay a percentage per pound for the food that we receive from the food bank—in 2013 this amount was \$1,961.29.

It is our hope that you will continue to be generous when you include FISH Fairborn in your 2014 budget for charitable giving. We continue to be a tax-exempt organization. Your donations make it possible for FISH volunteers to provide services to people in need in our community. May God bless you.
