The MVHF raised funds for the Diabetes Inpatient Team - Hospitalized patients receive care from certified diabetes' educators based at the Bull Family Diabetes Center. Since diabetes is primarily self-managed, education is essential in helping patients develop the skills to more effectively control the disease and reduce devastating long term complications. In 2013, certified diabetes' educators completed more than 1,800 patient visits. The program collaborates with the Diabetes Dayton, Juvenile Diabetes Research Foundation, Premier Community Health, local chapter of the American Association of Diabetes Educators and area hospitals

The MVHF raised funds for The Palliative Care team, which focuses on compassionate care for patients that require complex symptom management, or who are transitioning through the dying and bereavement process. The team provides coordinated nursing interventions along with educational, spiritual, psychological and emotional support to patients and their families. The Palliative Care Program provided care to more than 1,100 patients and families in 2013. The Palliative Care staff collaborate with Hospice of Dayton, the Dayton Area Palliative Care Education Consortium, Fidelity HealthCare and Wright State University College of Nursing and Health and School of Medicine

The following footnote is from the audited combined financial statements for Premier Health and affiliates: MedAmerica Health Systems (MAHS) is the parent organization of Miami Valley Hospital Foundation (MVHF). Premier Health (Premier), MedAmerica Health Systems (MAHS), Atrium Health System (AHS), and UVMC, Inc. (UVMC) have been determined by the Internal Revenue Service to be tax-exempt nonprofit corporations and public charities under Sections 501(c)(3) and 509(a), respectively, of the Internal Revenue Code. Samaritan Health Partners (SHP) is tax-exempt under Section 501(c)(3) and is a public charity by reason of being included in the group ruling issued to the U.S. Catholic Church. As tax-exempt organizations, their income is exempt from federal income tax except to the extent of any unrelated business activities. Taxes payable at December 31, 2013 and 2012 for such unrelated business activities are not significant. MAHS, SHP, AHS, and UVMC also own or control certain subsidiaries, which are for-profit corporations subject to federal income taxes. These are: * MVHE, Inc. and Premier Health Specialists, Inc. (formerly Health Specialists of Dayton, Inc.) (subsidiaries of MAHS); * Samaritan Family Care (subsidiary of SHP) and Samaritan North Surgery Center Limited (a joint-venture partnership of which GSH is an 80% owner); * Middletown Surgery Center, LLC (a joint-venture partnership of which AMC is an 80.5% owner) (subsidiary of AHS); * UVMC Management Corporation and After Hours Family Care, Inc. (subsidiaries of UVMC). Management annually reviews its tax positions and has determined that there are no material uncertain tax positions.

ANY PAYMENTS MADE AFTER THE 2-1/2 MONTHS WERE PROPERLY REPORTED ON PRIOR YEARS' FILED IRS FORM 990 RETURNS, DISCLOSING COMPENSATION EARNED BY THESE INDIVIDUALS UNDER THE PLANS FOR EACH SUCH YEAR. In addition to the supplemental nonqualified retirement plans noted above, the organization offers a 451 or 457(b) nonqualified deferred compensation arrangement to certain executives. All contributions to these plans are through employee elected deferrals. The following individual participated in either a 451 or 457(b) plan. J Michael Sims. The employee elected deferrals into these plans are properly reported as part of the compensation amounts report on Schedule J, Part II, Column B(iii). Part I, Line 6a & 6b. Premier Health (Premier), which Miami Valley Hospital Foundation is affiliated with, has an incentive component for all executive and director level employees that ties a portion of their total compensation to organizational and individual objectives and outcomes. The organizational criterion is weighted according to balanced scorecard categories: Positive Work Environment (15%), Quality (30%), Patient Satisfaction (15%), Physician Partnership (15%) and Financial (25%). The financial category of the scorecard is based on net earnings of the individual hospital and the net earnings of the system as a whole. This financial target is set based on the operating and cash flow margins required to maintain the system's Aa credit ratings. Incentive objectives for Directors and above are weighted 45% on organizational criteria, 45% on individual criteria, and 10% on Operational Effectiveness. The 2013 incentive plan amounts were paid to the participants in 2014. These are not reported as deferred compensation on the 2013 Form 990 based on the definition of deferred compensation contained in the Form 990 instructions. Per the instructions, "deferred compensation is generally treated as earned or accrued in the year that services are rendered, except when entitlement to payment is contingent on satisfaction of organizational goals or specified performance criteria (other than mere longevity of service) under the deferred compensation plan." Based on the incentive program criteria outlined above, we believe the incentive payments meet the exception noted in the instructions. Such amounts are properly reported as compensation for Form 990 purposes when included in the participants' Form W-2 wages.
