		CareSource, a leading nonprofit managed care organization based in Dayton, Ohio, has been living its mission to provide health care to those who need it most for more than 24 years. CareSource serves more than 972,000 Medicaid members in Ohio. CareSource's spectrum of services include: (1) Medicaid consumers, including families with low income, children, pregnant women and people who are aged, blind or disabled through execution of an annual Provider Agreement with the Ohio Department of Medicaid (ODM); (2) Qualified Health Plans, called CareSource Just4Me, offered through the Federal Health Insurance Marketplace, providing low-cost comprehensive coverage for individuals and families; and (3) Dually eligible consumers for Medicaid and Medicare through Ohio's Integrated Care Delivery System, MyCare Ohio. CareSource's mission is to make a difference in the lives of underserved people by improving their health care. At CareSource, our mission is one we take to heart. In fact, at CareSource, we call the Company mission our "heartbeat." It is the essence of our company and our unwavering dedication. It is a hallmark of CareSource's success. CareSource's health plans are founded on the principles of quality and service delivered with compassion and understanding. CareSource goes the extra mile to ensure members receive the highest quality of care. CareSource's commitment to quality is demonstrated through the Organization's National Committee for Quality Assurance (NCQA) and URAC accreditations. CareSource received a Commendable Accreditation for the Medicaid HMO Health plan Accreditation by NCQA. NCQA is a private, nonprofit organization dedicated to transforming health care quality through measurement, transparency and accountability. NCQA consistently raises the bar on health care plan performance by continually increasing quality improvement standards. Ohio, like other states, has put an increased focus on NCQA accreditation to ensure all Medicaid plans are ranked on a standard of quality and health outcomes. CareSource pursued NCQA accreditation in addition to maintaining its URAC Full accreditation for compliance with health utilization management and health call center. Certification by both NCQA and URAC demonstrate CareSource's commitment to quality and enhances CareSource's ability to improve the health and well-being of those we serve. In 1989, CareSource pioneered Ohio's first mandatory Medicaid managed care program. During CareSource's 24 years of operations, CareSource has experienced significant growth and is now one of the largest Medicaid managed care plans in the country. In Ohio, CareSource has garnered nearly 57% of the statewide managed care market share and has the highest voluntary enrollment rate and the lowest voluntary disenrollment rate of all participating Medicaid Managed care plans in Ohio. CareSource spends over 92% of capitation revenue on program-related expenses serving CareSource's Medicaid members and has a target administrative rate of 6.0%. CareSource's Ohio Medicaid programs serve Covered Families and Children (CFC), including Healthy Start and Healthy Families, members of the Aged, Blind or Disabled (ABD) population, and consumers eligible for the Home and Community Based Services (HCBS) waiver. CareSource's years of experience in managing Medicaid managed care programs and member-focused approach to care have allowed CareSource the opportunity to forge strong, positive regulatory relationships with state agencies, including with departments of insurance. At the core of its mission, CareSource focuses on prevention with a goal of improving member health, the quality of health care services received and accessibility of health care services for Medicaid members via an innovative health and wellness methodology. CareSource has a broad, statewide network of more than 25,000 providers, including primary care and specialist physicians, hospitals, nursing facilities, home health care agencies and other medical providers who provide medical services as well as assist in the coordination of member care. Additionally, CareSource offers 24-hour nurse call center coverage staffed by Registered Nurses to provide around-the-clock medical advice to access appropriate care and divert unnecessary emergency department visits. CareSource's community-based care coordination program serves our members who have the greatest need for case management services. Members receive enhanced care management services based on their complex physical, behavioral and social health needs. CareSource's community-based team of nurses, social workers and navigators, works in the community to guide members through the complex and often-confusing medical and social service systems. CareSource collaborates with community partners and providers such as the Area Agencies on Aging, Community Mental Health Centers, local Pharmacies, and Federally Qualified Health Centers to ensure our members receive the services they need. CareSource's unique face-to-face model allows us to have a holistic view of our members' needs reinforcing the direct link between the member, provider and health plan. CareSource has been expanding its reach to additional states and expanding services to more vulnerable populations beyond CFC and ABD. In 2013, CareSource prepared for the launch of MyCare Ohio, Ohio's Integrated Care Delivery System. CareSource entered into a three-way contract with Ohio and the Centers for Medicare and Medicaid Services (CMS) and will begin serving these new members in May 2014. By connecting Medicaid and Medicare, CareSource is helping Ohioans achieve better health outcomes and reducing unnecessary costs from fragmented health systems. With a go-live date of May 2014, CareSource members receive person-centered care management that coordinates their physical, behavioral, long-term care and social needs. CareSource successfully secured bids in 2013 through ODM to serve consumers in the Cleveland and Marietta regions of Ohio who are eligible for the Home Based Community Services (HCBS) waiver. Through this program, CareSource provides in-home and community-based care that helps individuals remain at home instead of residing in a nursing home or other long-term care facility. CareSource now serves more than 2,000 individuals on the waiver program. CareSource entered the Federal Health Insurance Marketplace in 2013 with its health insurance plan, CareSource Just4Me. CareSource Just4Me, an important part of the Organization's mission to serve the underserved, offers affordable coverage to those who need it most through low premiums, copayments and deductibles. Just4Me was successfully implemented with enrollment beginning October 1, 2013 with an effective date of coverage of January 1, 2014. More than 35,000 consumers enrolled in CareSource Just4Me, making it one of the most successful Marketplace plans to provide coverage to uninsured Ohioans. CareSource is exploring the possibility of entering other states in 2015 to provide health insurance options on the Marketplace. CareSource's innovative programs aim to improve health outcomes, while remaining member focused and treating the whole person. CareSource addresses not only a member's medical issues, but also a member's psychosocial issues that can create barriers to receiving quality health care. In 2012, CareSource launched a Medication Therapy Management (MTM) program with Outcomes MTM, a company that specializes in the design, delivery and administration of MTM programs. CareSource's MTM program engages community pharmacists to assist members with their pharmacy and overall health care needs. Pharmacists provide complete medication reviews to help members with their medications. By providing this service, CareSource has decreased unnecessary hospitalizations and emergency department visits. From July 2012 through June 2013, 52,485 CareSource members were enrolled. CareSource's innovative MTM program was awarded the Ohio Association of Health Plans Pinnacle Award in May 2013. CareSource provides enhanced benefits to members that are above and beyond required benefits defined by state or federal agencies. In order to ensure members are able to access the most appropriate medical care, CareSource provides transportation services for office visits to their medical provider's office, ensuring that members are keeping preventive, sick or follow-up appointments. Further showing CareSource's dedication to ensuring that our most vulnerable members receive needed care, CareSource does not charge Medicaid members a copayment for pharmacy products, dental visits, vision examinations, vision hardware or non-emergent emergency department visits, even though the regulations allow for such co-pays. To drive quality and achieve CareSource's health outcomes targets, CareSource incentivizes providers through a value-based incentive model. CareSource focuses efforts on creating incentives and reimbursement opt
