Programs and Services for Disadvantaged and At-Risk ChildrenFoundation grants supported several programs for homeless children, including a summer camp, and equipment and emergency support for two family shelters The Foundation awarded a grant to train CASA volunteers on the impact of heroin and opiate addiction on children, and another to train educators on the effects of, and interventions for, early childhood trauma Because good intervention programs can provide young people with alternatives to unhealthy behaviors, the Foundation supported grants to ballet performances and instruction, creative after-school programming for under-performing elementary school children, a model middle school for disadvantaged Latino children, a summer camp for children in K-5 to sustain knowledge and skills learned during the school year, nutrition education for families living in poverty, a community event to increase enrollment in childrens summer food programs, and a community fair to recruit adoptive and foster families

Early Care and Education, School ReadinessThe Foundations support for school-readiness programs included an early care and education initiative to ensure that more than 50,000 southern Arizona children enter school healthy, eager to learn, and ready to succeed, a preschool intervention program to help at-risk children acquire social and emotional skills needed for kindergarten, and literacy programs for young children at a museum, summer camps, in homes, and at community events The Foundation also made more than \$30,000 of in-kind contributions of early learning materials and backpacks filled with kindergarten readiness activities to Franklin County Family and Children First Council and Columbus Kids, benefitting several thousand young children and their families
