We obtain grants from other 501c3 non profits and use that money to give grants to schools so that they can have solar electricity and sometimes wind turbines at their schools. The solar and wind systems are small and are used for educational teaching tools and they do not save very much on the school's electricity bills. They are classroom teaching tools that just happen to also generate a small amount of solar electricity. The average cost of such a solar system is less than \$10,000. The wind systems are partial grants. The average cost of a wind system is \$25,000.

We obtain grants from other 501c3 non profits and use those funds to provide grants to schools for the purpose of each school obtaining an on line data collection system that they can use to help students learn about solar electricity in the classroom. The data is a live meter that measures the amount of solar electricity at that school. The data is then put on a public web site that allows students to study the data based on longitude and latitude. The web site is open and free of charge and because it is to be used for students we do not allow ads of any kind to appear on any of our web sites.
