Quivira is engaged in multiple public education and outreach efforts. Quivira conducts workshops and publishes a website, journals, eNewsletters, technical field guides and books to promote its mission. Quivira's annual conference provides a forum for ranchers, conservationists, public land managers, scientists and members of the public to discuss relevant issues related to progressive cattle management, land stewardship, and climate change resilience strategies.

Land and Water Program - represents Quivira's commitment to land health, restoration, education, collaboration and progressive stewardship of natural resources. This program has included a variety of work ranging from induced meandering projects to grassbanks and local food production. Currently, the program concentrates restoration and education efforts in north-central New Mexico, Quivira's Red Canyon Reserve in southern New Mexico, and in the Santa Fe and Las Vegas, New Mexico areas. Quivira also participates in various committees and coalitions that are also committed to implementing land health projects. Current and past land restoration projects include work on Comanche Creek, Dry Cimarron River, Canon Bonito Ranch, Mora River, Ponil Creek, and Cedro Creek. Quivira's Carbon Ranch program

Capacity and Mentorship - The Tribal Partnership Program assists three Chapters of the Navajo Nation (Ojo Encino, Torreon, and Counselor) to expand their efforts to build economic and ecological resilience. Principally this is done by helping these Chapters develop the capacity to plan and implement 1) ecological restoration and monitoring projects, 2) managed livestock grazing, 3) a proactive feral horse management program, and 4) a plan to re-localize food production and distribution. The New Agrarian Program creates apprentice and internship opportunities for the next generation of conservation and agrarian leaders. Quivira has partnered with a number of sustainable agriculture operations around the Southwest to offer apprenticeship opportunities for people with a sincere commitment to a life at the
