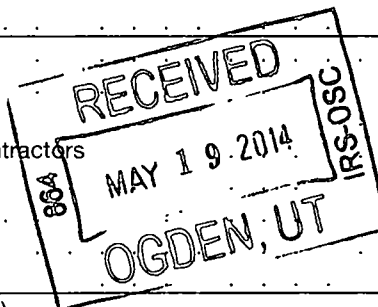

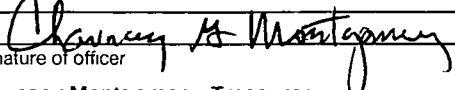

Value of shares in Columbia Large Core Quantitative Fund increased throughout 2013, ending at \$8.48 per share.

The fund's principle value increased approximately \$15,303 over the course of 2013.

Value of shares of Delaware County Bank and Trust stock increased to \$6.15 per share. The investment gained about \$26.

Ralph Gooding Local Charity Fund FBO Community Library Foundation, Inc increased in market value \$6,296.

The total increase of these assets, minus dividends paid and investment income, equals \$21,625 for 2013.
