The impact on our grants and work in the "prevention of family violence" service area helped reduce the health risks faced by victims of family violence. This service area empowers communities in Ohio to build coalitions that create comprehensive plans for breaking the cycle of family violence that threatens the physical, emotional, and social well-being of people of all ages, including the elderly. The focus is on stopping it before it happens.

4b (Code:) (Expenses \$ 35,791 including grants of \$ (70,776)) (Revenue \$)

The "oral health" service area supports projects that improve access to preventive oral health care, strengthen the capacity of safety net providers and encourage community-based prevention strategies. Oral health is the top unmet health need of all Ohioans and, while Medicaid promises a health safety net for the poor, there is virtually no safety net when it comes to dental care. Our grants and strategies have helped Ohio's poor receive dental care that they otherwise might not receive.

Note that the grants expense amount of \$(70,776) is a NEGATIVE amount because it includes a grant return of \$157,956

The "strengthening Ohio's safety net" service area supports the expansion of primary care services (including dental and mental) to more people and communities in need. This service area works in partnership with existing Community Health Centers and local communities/counties to develop a coordinated growth strategy to address unmet health needs and improve the delivery of cost-effective primary care and preventive health services. This service also invests in innovative strategies to increase the diversity and distribution of the healthcare workforce and enhance the recruitment and retention of primary care, dental, and mental health professionals in underserved areas within The HealthPath Foundation of Ohio's service area.
