Predisan USA Inc. exists as a Christian healthcare organization so that individuals and populations in the Predisan service area experience wholeness - Physical, spiritual, social, economic and environmental health - according to God's redemptive plan.  
"Predisan" comes from two Spanish words which mean "to proclaim" and "to heal" as in Luke 9:2 when Jesus called on the apostles "to proclaim the Kingdom of God and to heal the sick." This calling to love God and love people is what drives our work.

Predisan, a Christian mission founded in 1986, located in Catacamas, Olancho, Honduras focuses on three areas: medical care, community development and spiritual outreach. Predisan serves in Eastern Honduras through seven clinics providing approximately 76,000 patient encounters yearly. The center of the outreach is the Good Samaritan Clinic. This year the clinic provided medical services through 25,000 patient encounters for general medical care, and specialty care in dentistry, physical therapy, women's health, gastroenterology and gynecology; and outpatient surgery and specialty care by visiting physicians. The Center for Rehabilitation of Patients with Addictions (CEREPA) is also a major component of Predisan. Its program meshes a 12-step program with a Christian focus and professional care. This year, 143 patients were admitted to CEREPA's inpatient rehabilitation program. The Mountain Clinics and Healthy Communities Program work to improve life physically, spiritually, and economically. Six clinics provide prevention and community based primary health care. The Healthy Schools program provides more than 2,000 students in 43 schools with a vital healthcare package and daily nutritious food item. Predisan also provides scholarships for 153 elementary and high school students, as well as two college students.
