4a (Code) (Expenses \$ 285,253 including grants of \$) (Revenue \$) AEF COOL Program (College Opportunities for Life) - The Abilene COOL Program began in 2007 and provides four counselors (added two counselors in July 2012), two on each AISD high school campus, to identify students that need assistance regarding the college application process. In addition to assisting students in the completion of college applications, the COOL program organizes field trips to college campuses and helps students to find scholarships and funds for college. During 2013, the program received contributions of \$366,283 (\$352,622 to be received over a four year period) and incurred expenses of \$285,253. In 2012, the program received contributions of \$767,775 (\$600,000 to be received over a four year period) and incurred expenses of \$230,244.

4b (Code) (Expenses \$ 66,145 including grants of \$) (Revenue \$) AEF Teacher Grants (STAR & GIFT) - The AEF raises money each year to honor outstanding AISD teachers with classroom and instruction grants. These STAR (Supporting Teachers with Academic Resources) grants are provided to teachers after submission of grant request to fund school educational projects. 61 awards were provided to teachers during September 2013 to fund the educational projects of the school year for a total of \$54,426. The Judy Dudley GIFT (Giving to First-time Teachers) grants are awarded to AISD employees who are teaching for the first time. Grant funds are for additional classroom materials to enhance those provided by the school district. 69 GIFT grants were awarded during August 2013 for a total of \$10,350.

4c (Code) (Expenses \$ 15,592 including grants of \$) (Revenue \$) AEF Young Masters Program - The AEF Young Masters Juried Art Exhibition for Advanced Placement Art students celebrates young master artists and their dedicated teachers for demonstrating excellence in artistic education with a quality museum art exhibition. The Young Masters exhibition extends the supporting role of the AEF with AISD, and will impact the future of not only the students selected for the show, but all advanced placement art students by inspiring them to reach their full potential. Additionally, it provides students acclamation that may further enhance opportunities for acceptance into higher education art programs. A-P studio art students and art history students at both high schools participated in the 2013 exhibit being judged by an artist from Ft Worth, TX, resulting in 5 scholarships being award for a total of \$6,750.

Report on the Financial Statements

We have audited the accompanying financial statements of The Abilene Education Foundation (a nonprofit organization), which comprise the statements of financial position as of December 31, 2013 and 2012, and the related statements of activities, functional expenses and cash flows (direct method) for the years then ended, and the related notes to the financial statements, and the accompanying supplementary information, statement of cash flow (indirect method) for the years then ended.

Management's Responsibility for the Financial Statements
