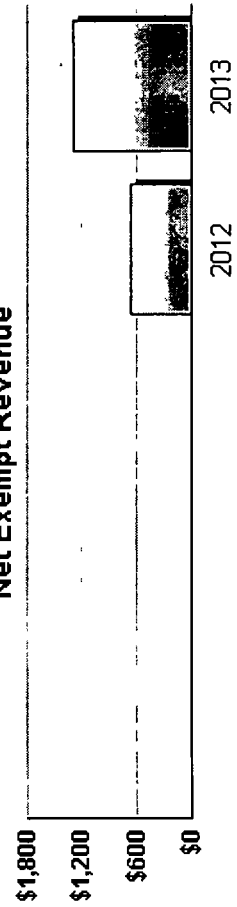
Exempt Revenue (Loss)

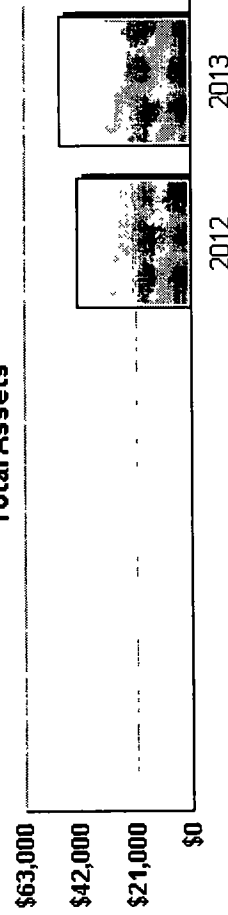

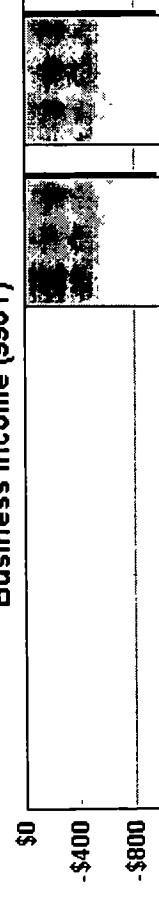
