WASH (clean water, sanitation, hygiene): ICDI's central African assets, infrastructure and strategic planning uniquely establish it as a key implementer of deep well water drilling in the Central African Republic (CAR). Two fully operational "down-hammer drilling" rigs, all the necessary supporting equipment and staff, together with a sophisticated support services infrastructure. ICDI is well placed to address the WASH needs that exist in central Africa, especially in the CAR. Additionally, ICDI's well repair teams through trained technical teams, accomplish an integration of getting the job done in the context of community development best practices and sustainable job creation. In calendar year 2013, ICDI drilled 76 new deep water wells and rehabilitated 153 pumps and wells.
 The combination of these programs ensured access to clean and safe drinking water for over 450,000 people.
 In addition to the implementation of clean water solutions, ICDI bundles new well projects with training in basic hygiene and the building of latrines, thus increasing the community health impact of ICDI's programs.

4b (Code:) (Expenses \$ 152,308 including grants of \$) (Revenue \$ 201,373)
Pump Maintenance: During the year ICDI started a separate program to maintain manual pumps in the Central African Republic. This program came from the need to fix broken and worn pumps before they reach a state of disrepair. The goal was to visit each pump in the program at least three times during the year and perform regular maintenance to ensure a constant uptime. Because of the March revolution, three visits were not possible, but 618 pumps were started on the program. On arrival, 85% of pumps were functional. On departure, 98% were functional. This program will continue into 2014 as security allows.

4c (Code:) (Expenses \$ 154,543 including grants of \$) (Revenue \$ 33,886)
Community Development: ICDI combined the Agriculture, Radio, and Micro-Enterprise programs into a complete community development focus. **Agriculture:** Pursuing its goals of eradicating hunger and malnutrition in the rural communities of the CAR, ICDI's agricultural program seeks the following objectives: (1) increasing nutritious food production through provision of basic farming tools, improved seeds and fruit seedlings, and small farm animals to family farmers; (2) strengthening the technical capacity of agricultural cooperatives through training of village agriculture technicians and best agriculture practices workshops, and (3) conducting targeted farmer-focused agricultural research to best serve impoverished African family farmers. **Radio** ICDI broadcasts on a shortwave frequency which is heard over the western part of the country. Programming is focused on reinforcing the hygiene message, general community advancement, and interviews.

This work came from the need to fix broken and worn pumps before they reach a state of disrepair. It was determined that this activity and funding was significantly different from the other Pump and Wells activity and a new program was started.

990 Part 3 Quest 3 Orphan care - During the year the Orphan care program was found to be outside the main vision of ICDI. The activities in CAR were taken over by VisionTrust, one of our largest donors who's main goal and operations are directed towards the needs of orphans and their care.

990 Part 3 Quest 4d: These amounts are the closing of the Orphan program and expenses for property maintenance in DRC

990 Part XII Line 2 - During the year, a revolution was started in CAR and violence continued into 2014. During this time, accounting documents were destroyed/lost/neglected. As such, a full audit of 2013 is not possible until stability returns to the country. A review of 2013 will be performed instead.
