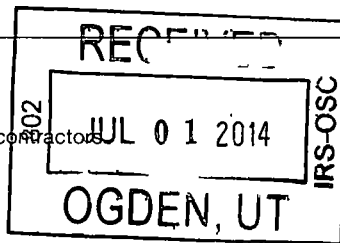

In 2013 Passion 4 People International proclaimed Christ to 39,156 people through 35 outreach services and events planned.

3,571 people reported making a decision to follow Jesus Christ or to rededicate their lives to Him. 1,782 slum children had their feet washed

as our teams prayed over them and shared the Gospel with them. 522 believers received training in lifestyle witness and evangelism. 202

pastors were trained in how to lead their congregations in evangelism and community outreach.

In addition, Brad Butcher helped Pearl City Church as a mentor to the pastors and overseeing marriage and family ministries, with an

emphasis on getting healthy so we can do more effective outreach and discipleship. Brad's hope is that in getting hands-on experience work-

ing in an Indian church, he can better help churches to engage in evangelism and follow-up discipleship in the future.

Brad and team did events in several cities in India including Vanasthalipuram, Vizag, Guntur, and Hyderabad. Events were also held in South

Africa and in the US.

Cityfest 2013 was held in Vanasthalipuram and attracted over 6,000 youth to the festival. An additional 18,000-20,000 were ministered to at the

schools, slums, churches and colleges by the team over a week's time.

Steps were also taken to start the Urban Outreach Institute and a future Cityfest in Vizag for 2015. A very fruitful and growing year!
