We are a catalyst and facilitator for outreach for people and their churches including recruiting, training, and sending missions leaders and teams, as well as inspirational outreach-oriented events and activities

Mobilized people and their churches to put their faith into action: Worked with members of more than 50 USA churches and hundreds of individuals in 2013 to facilitate and advance the Gospel and teachings of Jesus Christ to the extreme poor in the areas of greatest need in the world. We maintained and improved service to many of these churches, and also engaged in helping a number of new churches in 2013. We aided our partner churches with encouragement, creative ideas, opportunities and facilitation to partner with other churches and Christian missions and relief organizations, service and mission trip organization and training, child sponsorship campaigns, and raising funds for many and compassionate causes in their church and around the world. The results included a great many individuals and their churches coming alive in their faith and serving the poor of the world and in the USA. It also resulted in significant financial giving directly to the missionaries and Christian relief and development organizations that they became involved with. This included things like continuing and growing long-term support for more than 6000 needy children and their families through World Vision Child Sponsorship campaigns, conducted at church partners with the help of inspired and trained teams of volunteers who have participated in trips with us. Our Team FaithQuest activity is individuals and teams of many churches joining together to raise awareness and support for these missions activities, often with running, cycling, hiking, & other events that rally people and their churches to put their faith into action and share the story far and wide.

4b (Code:) (Expenses \$ including grants of \$) (Revenue \$)
Recruiting, training, and sending missions teams. We help churches in organizing and accomplishing missions trips that are with their team members, and run through their financial books not ours. We help recruit, train, and send the leaders and teams of these trips and work closely to help arrange critical components, best-practices, ministry partnership, and after-trip church action. We continue to take a leader role with some of the trips as well, including FaithQuest-led trips to work with partners in Malawi, India, and other parts of the world. A focus area is Malawi, where we introduced churches to our 6 strategic Y-Malawi Partners involved with evangelism and discipleship in rural village areas, medical teams of doctors and nurses, agriculture and food security projects, projects for economic development with micro-finance, emergency food response to areas struck by crop failures, childrens and youth outreach and recreational programs, leadership training for village chiefs, pastors, and teachers, construction projects, and connections with World Vision sponsored children and their families in the rural areas. Inspired and unpaid volunteers raised funds and served to help organize and achieve these accomplishments. 2013 was our biggest year for trips to Malawi, with 12 trips with 168 participants from more than 20 churches. This enabled church members and leaders to learn ministry needs first-hand, work and serve on the frontlines, complete many impactful projects, and see lives transformed. Both in the rural villages and their own!

Provided volunteer leadership for Y-Africa/Y-Malawi ministry movement, including mobilizing USA churches as well as African projects, partners and trips. FaithQuest leads in connecting and maintaining relationship with 28 USA churches for this movement. The programs and projects have included child sponsorship and support, water well, agriculture and food security initiatives, health and hygiene programs, schools, plus education & literacy projects, economic development through micro-finance, youth ministry, orphan and vulnerable children projects, HIV and malaria related initiatives and diverse evangelism and discipleship programs to advance the love and teachings of Jesus Christ. - In addition our Team FaithQuest program is individuals and members of many churches joining together to put their faith into action & share the story. This includes our Team FaithQuest Ragnar Relay, Big Ring Century, and a growing number of other faith and physical challenge related events.
Additional Explanation:
The above 4a, 4b, 4c, expenses & revenue are not allotted separately to each of the diverse activities supporting the mission. Additionally, the vast majority of FaithQuest programs are accomplished by recruiting, inspiring, and equipping volunteers in the local church who in turn work us and their churches and the Christian missions and relief organizations we introduce to them.
