LA JOLLA INSTITUTE IS A NONPROFIT BIOMEDICAL RESEARCH INSTITUTE RANKED AMONG THE TOP FIVE ORGANIZATIONS IN THE WORLD FOR RESEARCH IMPACT IN IMMUNOLOGY SPECIFICALLY, OUR SCIENTISTS CARRY OUT RESEARCH TO UNDERSTAND HOW THE IMMUNE SYSTEM WORKS, AND TO APPLY THAT KNOWLEDGE TO PREVENT OR CURE DISEASE IMMUNE SYSTEM DISORDERS AFFECT MILLIONS AND INCLUDE MANY OF SOCIETY'S MOST DEBILITATING ILLNESSES OUR RESEARCH FOCUSES ON FIVE MAJOR AREAS 1 AUTOIMMUNE DISEASES SUCH AS TYPE 1 DIABETES AND RHEUMATOID ARTHRITIS 2 CANCER AND STIMULATING ANTI-TUMOR RESPONSES 3 INFECTIOUS DISEASES AND VACCINE DEVELOPMENT TO COMBAT TUBERCULOSIS, FLU, DENGUE VIRUS, AND OTHER DANGEROUS PATHOGENS 4 ALLERGY AND ASTHMA AND CONTROLLING HARMFUL IMMUNE REACTIONS 5 VASCULAR IMMUNOLOGY INCLUDING HEART DISEASE AND TYPE 2 DIABETES ADVANCE THE DEVELOPMENT OF VACCINES AGAINST DEADLY PATHOGENS SUCH AS MALARIA, TUBERCULOSIS, AND DENGUE FEVER, WHERE NO EFFECTIVE VACCINES CURRENTLY EXIST SINCE ITS FOUNDING IN 1988 AS AN INDEPENDENT, NONPROFIT RESEARCH ORGANIZATION, THE INSTITUTE HAS MADE NUMEROUS ADVANCES LEADING TOWARD ITS GOAL LIFE WITHOUT DISEASE THE INSTITUTE IS HOME TO 23 INDEPENDENT LABORATORIES, EACH OPERATED BY A LEADING SCIENTIST, SUPPORTED BY MORE THAN 350 EMPLOYEES - ABOUT HALF OF WHOM HOLD DOCTORAL DEGREES (PH D OR M D) FROM NUMEROUS COUNTRIES AROUND THE WORLD EACH OF THESE LABS IS DEDICATED TO UNDERSTANDING THE INTRICACIES AND POWER OF THE IMMUNE SYSTEM SO THAT THE KNOWLEDGE GAINED CAN BE APPLIED TO PROMOTE HUMAN HEALTH AND PREVENT A WIDE RANGE OF DISEASES ALTHOUGH RELATIVELY YOUNG, THE INSTITUTE HAS ACCOMPLISHED MUCH IN ITS SHORT HISTORY, AND WAS RECENTLY RANKED AMONG THE TOP FIVE ORGANIZATIONS FOR RESEARCH IMPACT IN IMMUNOLOGY WORLDWIDE (AS MEASURED BY CITATIONS PER SCIENTIFIC PUBLICATION) BY THE RATING AGENCY THOMSON-REUTERS IN ADDITION, THREE OF ITS SCIENTISTS ARE AMONG THE MOST HIGHLY CITED IMMUNOLOGISTS IN THE WORLD -- A DISTINCTION HELD BY LESS THAN ONE HALF OF ONE PERCENT OF ALL PUBLISHING SCIENTIFIC AUTHORS SEVERAL OF ITS FACULTY MEMBERS ALSO SERVE ON NATIONAL INSTITUTES OF HEALTH (NIH) GRANT REVIEW PANELS, WHICH ARE APPOINTMENTS THAT SIGNAL A HIGH DEGREE OF RESPECT FROM PREVIOUS YEAR ALONG WITH INCREASING IN NUMBER, MANY OF THE INSTITUTE'S 2013 PAPERS WERE PUBLISHED IN HIGH-IMPACT, HIGH-PRESTIGE JOURNALS, A REFLECTION OF THE EXEMPLARY QUALITY OF THE INSTITUTE'S RESEARCH THE INSTITUTE'S MAJOR PUBLISHED FINDINGS IN 2013 ILLUSTRATE THE RANGE AND POWER OF IMMUNOLOGY RESEARCH AND ITS IMPACT ON A BROAD GROUP OF HUMAN HEALTH ISSUES THIS INCLUDED DR SHANE CROTTY'S DISCOVERY, PUBLISHED IN THE JOURNAL IMMUNITY, THAT CERTAIN HELPER T CELLS ARE IMPORTANT FOR TRIGGERING A STRONG ANTIBODY RESPONSE AGAINST HIV, THE VIRUS THAT CAUSES AIDS THIS MAJOR FINDING WILL SIGNIFICANTLY ADVANCE EFFORTS TO CREATE THE WORLD'S FIRST ANTIBODY-BASED AIDS VACCINE AS PART OF HIS FINDINGS, DR CROTTY ALSO DEVELOPED A ROBUST TEST FOR IDENTIFYING PHENOTYPIC MARKERS FOR A TYPE OF T CELLS IN THE BLOOD, A MAJOR NEW TOOL FOR AIDS RESEARCHERS AMONG THE INSTITUTE'S OTHER MAJOR FINDINGS IN 2013 WERE DR S PATRICK HOGAN, ANJANA RAO, AND SONIA SHARMA'S DISCOVERY, PUBLISHED IN NATURE, THAT A CERTAIN TYPE OF PROTEIN, CALLED SEPTINS, PLAY A CRITICAL ROLE IN ACTIVATING A CALCIUM CHANNEL ON THE SURFACE OF T CELLS THAT IS NECESSARY FOR THEIR SURVIVAL, ACTIVATION, AND ABILITY TO FIGHT DISEASE, DR ALEX SETTE'S FINDING THAT T CELLS PLAY AN IMPORTANT PROTECTIVE ROLE IN CONTROLLING DENGUE VIRUS INFECTION, RATHER THAN CREATING AN ABERRANT RESPONSE THAT CAN ULTIMATELY WORSEN THE DISEASE AS IS THE PREVAILING BELIEF IN THE SCIENTIFIC COMMUNITY, AND DR HILDE CHEROUTRE'S DISCOVERY OF THE MECHANISM THAT ENABLES CD4 HELPER T CELLS TO ASSUME THE MORE AGGRESSIVE ROLE OF KILLER T CELLS IN MOUNTING AN IMMUNE ATTACK AGAINST VIRUSES, CANCEROUS TUMORS, AND OTHER DAMAGED OR INFECTED CELLS THE FINDING, MADE IN COLLABORATION WITH RESEARCHERS FROM THE RIKEN INSTITUTE IN JAPAN, COULD ENABLE THE DEVELOPMENT OF MORE POTENT DRUGS FOR AIDS, CANCER, AND MANY OTHER DISEASES BASED ON USING THIS MECHANISM TO TRIGGER LARGER ARMIES OF KILLER T CELLS AGAINST INFECTED OR DAMAGED CELLS IN ADDITION, IN 2013 THE INSTITUTE SAW CONTINUED ADVANCEMENT OF ITS RESEARCH DISCOVERIES BY INDUSTRY PARTNERS IN THE PHARMACEUTICAL PIPELINE, INCLUDING ONE THERAPY FOR PSORIASIS AND ORGAN TRANSPLANT ENTERING PHASE II THE INSTITUTE ALSO FORMED ADDITIONAL RESEARCH COLLABORATIONS WITH OTHER PHARMACEUTICALS TO HELP TRANSLATE EARLY STAGE RESEARCH FINDINGS INTO NEW THERAPIES FOR THE TREATMENT AND PREVENTION OF VARIOUS DISEASES OTHER MAJOR HIGHLIGHTS IN 2013 INCLUDE -RECOGNIZED AS A "BEST PLACE TO WORK" IN THE U S RESEARCH COMMUNITY -- THE INSTITUTE EARNED THE NATION'S NUMBER 1 SPOT FOR "BEST PLACES TO WORK IN ACADEMIA" BASED ON A SURVEY CONDUCTED BY THE SCIENTISTS MAGAZINE OF MORE THAN 1,200 FULL-TIME LIFE SCIENTISTS WORKING IN ACADEMIC OR NONCOMMERCIAL RESEARCH INSTITUTIONS WORLDWIDE THE INSTITUTE ALSO RESPONSES, AND CHAN-WANG LIO, WHO IS STUDYING NOVEL MOLECULES BELIEVED TO INFLUENCE LEUKEMIA DEVELOPMENT IN ADDITION TO THEIR RESEARCH ACTIVITIES IN 2013, INSTITUTE SCIENTISTS ALSO LECTURED AT MEDICAL RESEARCH SEMINARS THROUGHOUT THE WORLD AND ORGANIZED NUMEROUS SCIENTIFIC CONFERENCES WHILE IT IS DIFFICULT TO DETERMINE THE NUMBER OF PERSONS BENEFITED BECAUSE OF THE BROAD APPLICABILITY OF LA JOLLA INSTITUTE'S FINDINGS AND ACCOMPLISHMENTS, THE INSTITUTE ESTIMATES THAT THOUSANDS OF RESEARCH AND CLINICAL SCIENTISTS ATTENDED THE ABOVE MENTIONED CONFERENCES, READ THE INSTITUTE'S PUBLICATIONS, AND/OR DIRECTLY COLLABORATED WITH OUR SCIENTISTS, AND AS A RESULT, NOW INCORPORATE PORTIONS OF OUR RESEARCH INTO THEIR WORK TO BETTER UNDERSTAND THE COMPLEXITY OF HUMAN BIOLOGY TO MORE EFFECTIVELY FIGHT DISEASE
