The Wyland Foundation held numerous educational outreach tours, special events, and classroom presentations Following are 2013 event highlights National Mayor's Challenge for Water Conservation, 2013 The National Mayor's Challenge for Water Conservation entered its sophomore year as a national water conservation program Residents in all 50 states made more than 44,000 online pledges to save water, use less energy and reduce pollution in four categories home, yard, community, and life with potential cost savings of more than \$30.6 million The challenge had official participation from 70 mayors across the U.S., including Denver Mayor Michael B Hancock, D.C. Mayor Vincent C Gray, Columbus, Ohio Mayor Michael B Coleman, Seattle Mayor Mike McGinn, Tucson, Ariz Mayor Jonathan Rothschild and Santa Fe, N.M. Mayor David Coss The Mayors Challenge included a new element this year an eight-state U.S. environmental educational tour to schools and communities, reaching 4,000 students Water Is Life Classroom Mural and Art Contest The contest, inspired by the growing demands on U.S. water resources, took place Oct 21-Nov 21, and drew more than 9,000 students across 45 states Participating students painted 50 square-foot murals depicting the range of habitats and uses for water throughout the United States As part of the competition, the Wyland Foundation and its partners provided schools in over 300 cities with paint supplies, educational materials, and 50 square foot canvas murals as part of a national focus for students use of art as a method of exploring the economic, cultural and aesthetic value of American waters Waste to Wow campaign for the creative reuse of plastic liquid containers Contest to raise awareness about the growing number of plastic water bottles that are among the most common debris materials found in southern California storm channels The campaign reached over 100,000 people and was part of the foundation's efforts to support the County of Orange's Adopt A Channel Campaign to reduce debris from washing into the ocean "Maddie's Ocean" 7-City Educational Outreach Tour Visit Title I schools in seven Southern California communities, from El Centro to South Central Los Angeles Jan 17 - Feb 17, 2013, the Wyland Foundation in partnership with the Maddie James Foundation inspired over five thousands children in underserved communities about the conservation of ocean and waterways As part of the campaign, the foundation donated multi-day "ocean" experiences to Southern California schools from El Centro to South Central Los Angeles, including stops by the Wyland Clean Water Mobile Learning Experience, guest speakers and art activities Earth Month Heroes Wyland Foundation in partnership with KCAL / KCBS nominates individuals across Southern California who are having a positive impact on our environment to be Earth Month Heroes Each hero receives a stipend for the environmental charity of their choice Since beginning our partnership with KCAL / KCBS in 2011, we have given away over \$25,000 in grants and awards to support Southern California's environmental heroes The campaign is in conjunction with a month of Wyland Foundation public service announcements on KCBS / KCAL promoting smart water use in southern California Our Watersheds, Our Legacy 2013 National Tour In Fall 2013, the Wyland Foundation and the U.S. Forest Service joined forces on a national tour to tell the story of our nation's water - from its origination at the top of the watershed to its long journey to the sea This tour covered numerous states, including Ohio, Wisconsin, Missouri, West Virginia, Virginia, and Florida, culminating with the Big E Festival in Springfield, Massachusetts Art Lessons in the Wild The Wyland Foundation teamed up with Dana Wharf during the winter gray whale migration season to offer Wyland Dolphin and Whale Adventures, Art Lessons in the Wild This three-hour activity aboard a 63' Catamaran included a dockside presentation and art lesson, via video feed, by Wyland and an excursion at sea with an experienced naturalist Comics for Conservation In Spring 2013, the Wyland Foundation in partnership with Improv Comedy Clubs launched a social media public service campaign featuring the world's best known comedians to promote a sustainable environment
