In December 2013, funds were sent to Head Lama of the Tibetan Nyingmapa Meditation Center for the 25th Annual World Peace Bodh Gaya Tibetan Buddhist Nyingma Ceremony held January 30-Feb 9 2014 in Bodh Gaya INDIA. About 8000 participants were in the assembly and 3000 monasteries received Tibetan texts. Over 15,000 prayer wheels were offered. Meals were prepared and distributed to the local poor in Bodhgaya. Over 10,000 lay people also attended the World Peace ceremony and received numerous religious art thanka prints. 1,000,000 butter lamps were offered during the ceremony. Daily offerings were given to the monastics attending to help offset their travel to and expenses during the ceremony.
