Missionary Outreach Program Throughout 2013, donated materials and financial assistance were given to projects in Africa, Mexico and India Event highlights include Project Gulu - Family Care Uganda2013 was a big year of progress, growth and expansion for the Family Care Uganda team in Gulu Although they had made a lot of progress in setting up and renovating some old buildings to use as classrooms to educate the 160 children who attended their school in 2012, their numbers were growing and they discovered that they needed a larger, more versatile school complex Since the FCU schools students are all disadvantaged children, some of whom have been child soldiers themselves, are children of child soldiers or who come from refugee camps, having a safe place for the children to live during the school year as they got their education was the next logical step So, in February 2013, the FCU team secured the use of a plot of land on which to build a new school and housing complex to suit their needs As of the end of 2013, thanks to funding received from Activated Ministries, the school complex now includes 9 classrooms and dorms for the children, showers and toilets, 9 staff houses for teachers and school staff, a cement food storage, room for a volleyball court, netball and football, and a nearly finished kitchen Together with the local community, FCU staff and students have also worked together to set up and operate a large, self sustaining farm to grow/raise some of their own food They are also able to supplement their income by selling surplus food In addition to new construction, Activated Ministries funding has also paid the bills and salaries of local teachers and staff caring for and educating the children living at the FCU facilities Values in Education - IndiaActivated Ministries once again sponsored Values in Education efforts to donate twenty two values based libraries/curriculums to schools, childrens homes and centers for the disabled throughout India VIE volunteers personally delivered the curriculums to the various centers and hosted workshops and training sessions for the teachers and staff of the various institutions to help them incorporate the curriculums into their educational programs Approximately 5,000 children are benefiting from the donated VIE curriculums For full details, please read the compelling reports from all 2013 Programs at <http://www.activatedministries.org/projects>
