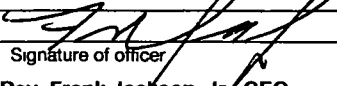

Assisting two faith-based organizations in the formation of their California nonprofit formation documents, and 1023 application. Each submitted a check in the amount of \$450 for the IRS application filing fee. Fee will be issued from VSF account upon completion.

PART III, LINE 28 - PROGRAM SERVICE ACCOMPLISHMENTS

The program is funded by the California Public Utilities Commission. There are three stages to the program. VSF is contracted through 2014 as an outreach and assessment stage 1 agency. Responsibilities under the contract include: educating customers on the benefits, income guidelines/requirements, and screening customers for eligibility. through the CARE and FERA programs income eligible SCE customers receive up to 30% discount off their monthly energy bill. In addition, eligible customers are provided free appliances and installation of energy-efficient refrigerators, air conditioners, CFL bulbs and lamps, as well as home weatherization efficiency solutions. The ESA program fits in line with the BBCI's Seed Project Financial Wellness program. The minimum household income ranges from "up to \$22,340 for a household of 1, up to \$77,780 for a household of 8. the VSF team, including independent contractor trained by VSF, conducted 400+ ESA program assessments with 98% low-to-moderate income qualified; 85% completed ESA education; and 60% receiving ESA efficiency solutions (and/or refrigerators, CFL bulbs, lamps, smart power strips, weatherization).

PART III, LINE 29 - PROGRAM SERVICE ACCOMPLISHMENTS

The BBCI Seed Project's Financial Wellness Program, host an community event with Wells Fargo Bank, Bank of America, JP Morgan Chase, Orange County Neighborhood Housing Agency, City council of Santa Ana, and a colloboration of faith-based organizations located in the City of Santa Ana. workshops were conducted in the areas of household budgeting, financial stewardship, and credit tools. In addition, 30 families were assisted with the modification processing of the mortgage loan with 26 receiving direct assistance. a small business workshop was also held with two attendees receiving direct assistance with the formation and filing of their corporation, and IRS 1023 application. In total, 75 families and/or individuals received some form of assistance.
