Provided 19 water projects within the Trichy District of Tamil Nadu along with funding a reverse osmosis project for a hospital and a medical camp. Additionally provided financial assistance for Annai Erica Public School and Orphanage for books, material, food, teacher salaries and other miscellaneous expenses benefiting 1,000 students. All of this work carried out was executed through our indigenous partner, Depressed People's Welfare Association. The impact of the water projects and monthly support towards Annai Erica Public School is estimated to be around 11,000 rural men, women and children.

Provided financial assistance to a hospital which helped support their outreach efforts towards patients affected by HIV and Leprosy; funds were used for medicines and other expenses necessary for the care of these patients.

4b (Code:) (Expenses \$ 87,515.00 including grants of \$ 76,281.00) (Revenue \$ 4,748.00)

Provided 27 water projects within the state of Andhra Pradesh with 24 of them being executed by our indigenous partner, Nazareth Association for Social Awareness. In addition to the water projects, assistance was also provided to those adversely affected by leprosy, HIV/Aids along with a medical and dental camp benefiting rural men, women and children. The impact of the water projects along with the care given in the medical and dental camps and village level outreach programs to the various people groups, estimates out at 15,000 rural men, women and children.

4c (Code:) (Expenses \$ 39,535.00 including grants of \$ 28,301.00) (Revenue \$ 4,748.00)

Provided 11 water projects in North India along with 200 portable water filtration units as part of our cyclone relief efforts. Our work was taken up by indigenous partners, Society for Transformation, Education and Progress and Ashirwad Sewa Kendra Trust. Estimated number of men, women and children benefiting from the water projects and the water filters is 1,000. For our STEP partner we provided a generator to handle the electricity needs when the campus experiences power cuts and a motorcycle to handle the transportation needs of the workers managing our projects within the villages.
