	MARY'S MEALS USA CONTRIBUTED GRANTS TO THE MARY'S MEALS GLOBAL ORGANIZATION AND ITS PARTNERS. THESE GRANTS MAINLY SUPPORTED PROGRAMS IN MALAWI, LIBERIA AND HAITI. IN MALAWI AND LIBERIA, MARY'S MEALS GLOBAL ORGANIZATION DIRECTLY DISTRIBUTES THE FOOD TO EACH SCHOOL AS WELL AS MONITORS THE FEEDING PROGRAMS THERE. MALAWI REMAINS ONE OF THE POOREST COUNTRIES IN THE WORLD AND FACES HUGE CHALLENGES IN EDUCATION AND CHILD NUTRITION. IN ADDITION TO PROVIDING GRANTS FOR THE GENERAL FEEDING PROGRAM IN MALAWI, US SPONSORS DESIGNATED FUNDS FOR 13 PERMANENT KITCHENS AT EXISTING SCHOOLS WHERE VOLUNTEERS CAN SAFELY PREPARE THE DAILY MEAL FOR THE CHILDREN USING ENVIRONMENTALLY FRIENDLY ROCKET STOVES OR INSTITUTIONAL BRICK STOVES. ALSO IN MALAWI, SUPPORTERS DESIGNATED FUNDS FOR FEEDINGS AT 14 SPONSORED SCHOOLS. THE MEAL IS USUALLY LIKUNI PHALA (HOT PORRIDGE FORTIFIED WITH VITAMINS AND MINERALS) GROWN LOCALLY WHEN POSSIBLE. IN LIBERIA, MARY'S MEALS GLOBAL ORGANIZATION OPERATES IN 4 COUNTIES: BOMI, CAPE MOUNT, GBARPOLU AND MONTSERADO. MANY OF THE SCHOOLS ARE IN REMOTE LOCATIONS, DEEP IN THE RAINFOREST AND ONLY ACCESSIBLE BY DIRT ROADS. IN ADDITION TO GRANTS FOR GENERAL FEEDING, US SPONSORS DESIGNATED FUNDS FOR FEEDINGS AT 3 SPONSORED SCHOOLS. THE MEAL THERE CONSISTS OF CORN SOYA BLEND PORRIDGE TWICE A WEEK AND A RICE MEAL THREE DAYS A WEEK. THESE MEALS ARE SUPPLEMENTED WITH FRESH VEGETABLES FROM THEIR COMMUNITY SCHOOL GARDENS. THIS ALSO TEACHES THE CHILDREN ABOUT AGRICULTURE. TYPICAL CROPS ARE POTATO GREENS, CASSAVA, PEPPER, BITTERBALL AND CABBAGE. IN HAITI, ONE OF THE POOREST COUNTRIES IN THE WESTERN HEMISPHERE, FUNDS SUPPORTED PARTNER ORGANIZATIONS IN CITE SOLEIL, GONAIVES & HINCHE WITH SCHOOL MEALS OF TYPICALLY RICE AND BEANS WITH SAUCE. IN 2013, THE NUMBER OF CHILDREN BEING FED BY MARY'S MEALS GLOBAL ORGANIZATION INCREASED TO 869,192 FROM 734,192 IN 2012.
