Part III Line 4a-The Early Childhood Resource Center (ECRC) is a ministry of the Sisters of Charity Foundation of Canton. ECRC is dedicated to improving the quality of childcare in Stark and the surrounding counties. This is accomplished by providing training and networking opportunities as well as an extensive resource library to members. The members consist of families with young children, child care staff and community agencies serving families with young children. In 2013 ECRC provided 497 hours of professional development training and 2,370 members participated in ECRC's workshops. Thirty three career development training (CDA) classes were provided to childcare workers who are working to attain CDA credentials and thirteen childcare workers completed the CDA classes. ECRC maintains a production lab that is available to all members for a nominal annual fee. Members can use the lab to provide educational age appropriate materials and activities for preschool children. In 2013, the production lab was used 2,181 times. ECRC also provides accreditation and support services for home day care providers who wish to obtain NAFCC or NAEYC accreditation. In 2013 ECRC offered over 296 family programs that focused on literacy, math, music, social studies and science. These programs were attended by approximately 4,270 people. ECRC also provides backpacks with age appropriate items that libraries and daycare facilities can purchase to provide educational preschool materials and activities for the children in their care.

Part III Line 4b - In 2013, ECRC took over the supervision of the Supporting Partnerships to Assure Ready Kids (SPARK) program from the Sisters of Charity Foundation of Canton. This is a home-visitation model that focuses on kindergarten readiness. There were 450 children that participated in Stark County in the program in 2013. The program is expected to serve an additional 150 children and their families in Stark County during the 2014-2015 school year.

Part VI Line 6, 7a & 7b - Sisters of Charity Foundation of Canton is the sole member of the Early Childhood Resource Center (ECRC). Reserved powers of the member include the power and authority to borrow or lend money, the purchase and sale of certain property, the appointment and renewal of the code of regulations and articles of incorporation, the election of directors, and the determination of corporate philosophy.
