Core competencies include activities associated with applied research, public policy analysis and advocacy, communications, and community affairs. These activities are essential to the effective operation of the Organization. In 2013, major activities by work area included: The Board of Directors and Administration provided oversight to the program and operations of the Organization ensuring integrity to the mission and financial stability; They monitored progress on the five, five-year program priorities they selected in late-2009 (NEORIO: Northeast Ohio Regional Impact and Outcomes [previously Indicators and Objectives], Fiscal Policy, Community Health, Older Adults/Long-term Care, and Child/Youth Development); oversaw and participated in planning the Centennial celebration, and began planning for an executive transition at the end of 2014. The Research team provided specialized data for a variety of groups to inform their decision-making processes. This included work for United Black Fund of Greater Cleveland, United Way of Medina County, United Way of Greater Cleveland, Preterm, Lorain County Community College, Northeast Ohio Sustainable Communities Consortium, and Cuyahoga County Board of Health. The team's three papers examining opportunities for sharing services in health and social services in Ohio advanced conversations in the areas of public health, adult protective services, and child welfare programs. The Center for Community Solutions staff testified during the state budget process and presented their work to a variety of stakeholder groups. In addition, the team began planning for the creation of Northeast Ohio Advocacy, Collaboration, and Transformation for the Social Services (NEO ACTS), a new coalition to provide training and networking opportunities for those in the social services field. The Public Policy team managed several projects throughout 2013. In January, the team released an updated and expanded edition of Richard G. Sherdan's Follow the Money: State Budgeting in Ohio. This volume is the premier non-partisan source for explaining the politics, institutional history, and detailed process behind the state budget. It was distributed to all members of the legislature, the governor's office, and to major cabinet departments, and it was used in a graduate-level course at the Voinovich School for Public Affairs at Ohio University. The project was advised by a bi-partisan group of senior budget experts from the public and private sectors, demonstrating Community Solution's commitment to seeking input from a wide variety of sources. The team also released a groundbreaking report on mental health entitled By the Numbers 2: Developing a Common Understanding for the Future of Behavioral Health Care (Dec. 2012), in partnership with the Mental Health Advocacy Coalition (MHAC). In anticipation of Medicaid expansion, By the Numbers 2 provides the first comprehensive look at local mental health boards' spending on supportive services, such as housing, that are not covered by Medicaid. The Communications/Development team expanded its use of electronic tools to disseminate information and analysis provided by other teams, created a new Website, secured contributed dollars to support Organizational activities, worked with other teams to plan and present multiple sessions of the Human Services Institute, planned and implemented the Centennial Celebration in partnership with United Way Services of Greater Cleveland, and administered two annual community awards programs.

In addition to helping to secure the expansion of Medicaid coverage for low-income adults and working with other program teams, the Community Health team wrapped up the Organization's 30+-year role as the regional administrator of federal Title X family planning funds, supporting comprehensive family planning services at health care facilities around Northeast Ohio. This critical step was taken in compliance with the Board of Directors' strategic planning decision from late 2012.
