The Society for Cardiovascular Angiography and Interventions Foundation (the Foundation) promotes excellence in invasive and interventional cardiovascular medicine through physician education and representation, and the advancement of quality standards to enhance patient care. Emphasis is placed on registration of all procedures performed by members, development of quality standards for laboratories, establishment of criteria for credentialing physicians and directors and presentation of guidelines for training in cardiac cardiovascular angiography. Focus areas for the Foundation include establishing standards and guidelines for all aspects of cardiac cardiovascular angiography, training, credentialing, safety and quality assurance for cardiac procedures.

The Foundation's three largest program services based on expenses included its Annual Scientific Sessions, Interventional Cardiology Fellows Course and Women in Innovations (WIN). The Annual Scientific Sessions features sessions that provide maintenance of certification as part of the Foundation's ongoing partnership with the American Board of Internal Medicine, multiple breakout sessions on the latest updates in the field and a number of late breaking clinical trials. The Interventional Cardiology Fall Fellows Course is a course for interventional cardiology fellows. The annual course features didactic lectures by the leaders in the field, hands on simulation training, and important networking opportunities for fellows who attend the course. WIN is an effort devoted to improving the overall approach to the medical treatment of women with cardiovascular disease by offering an integrated spectrum of educational programs in the field.
