What is the organization's primary exempt purpose?

Springboard Innovation is a social enterprise that builds critical infrastructure to enable citizen innovators to lead social change. The Organization operates programs built around a framework of four integrated initiatives to increase the capacity of individuals and enterprise to solve community problems. It is a comprehensive approach that seeks to cultivate an "innovation ecosystem" model in which change leaders can flourish in any community. 1) Teach the change maker inside each of us, 2) Convene community innovators for action, 3) Fund social innovation by helping create and utilize new tools that grow community capital, 4) Build the municipal ecosystem for change.

Describe the organization's program service accomplishments for each of its three largest program services, as measured by expenses. In a clear and concise manner, describe the services provided, the number of persons benefited, and other relevant information for each program title.

28 ChangeXchange Capital is a key barrier to social enterprise, especially in rural parts of our country. Springboard Innovation has expanded direct service to rural regions of Oregon, helping foster leadership and building local investing infrastructure. Using ChangeXchangeNW, the Northeast Oregon Economic Development District (NEOEDD) in NE Oregon has built a regional team, and now has a Node on CXCNW. Their team of community leaders has developed a plan based on Springboard Innovation's comprehensive work on how to grow community capital by retaining and re-circulating dollars in rural communities, forming a regional approach to economic development. The goal remains connecting the dots between socially-minded investors with locally owned companies. They are poised to enable their communities to invest in themselves. Our contract continues into end of 2014, during which we plan to offer six workshop titles, training local trainers, and building capacity in local service providers. (In 2014 ChangeXchangeNW will change its name to Hatch Capital.)

29 Hatchlab We found the perfect space for HatchLab, and signed the lease in June 2013. The capital raising and subsequent build-out began in summer. Finally, the Hatch Grand Opening was held January 30, 2014, and nearly 200 people attended, almost exceeding our capacity in the 13,000 sq ft. We now offer ten offices, ten cubes (called Fireboxes), and four Window Box Desks, along with co-working space, conference rooms, a cell phone booth, and 20 workshops a month by local experts who provide their services free to Hatch members. We will only lease to enterprises with a mission to improve communities, whether locally or globally. We also attract volunteers, professionals, community members, and students who come to meet people, and hear how Hatch was born. Tenants who have already signed leases include Albina Opportunities Corporation (AOC), a local Community Development Finance Institution (CDFI), Family Forward, a non-profit that support family friendly policies and programs, Impact Flow, a social enterprise that helps people become philanthropists, and the Harbourton Foundation. Many more social entrepreneurs in the early stages have found Hatch to be a critical resource as they plan to launch change into the world.
