VII. Form 990 Part VI, Section A, Line 4 The By-Laws of Jackson County Rural Electric Membership Corporation were amended on
November 5, 2013. Article I, "Membership," Section 8, point 8.03 was changed to preserve the rights of both former spouses
upon a divorce or legal separation; formerly all rights transferred to the spouse remaining with the premises.

Article XI, "Non-profit Operation," Section 2, point 2.01 was amended to state that capital allocation notifications were required to "active"
patrons so that bill statements notices would largely suffice, and that allocation of inactive members can be obtained by contacting the
