

Part I, line 10. The \$99,000 grant was made to the Birdies for the Brave, part of the PGA Tour Charities, Inc. a 501-c-3 organization. This grant was then donated in its entirety to three charities and a golf course run by the US Marines as follows: The Marine Corps Community Services South Carolina, received a handicapped golf cart valued at \$4,000 for use by handicapped players at The Legends golf course on the Parris Island Marine base, Operation Homefront, \$15,000 in cash and \$15,000 of specialized handicapped equipment, Military Warrior Support Foundation, \$50,000 and Speical Operations Warrior Foundation, \$15,000.

Part I, line 16. The major expenses included on line 16 include \$15,785 paid to Hampton Hall Club for use of the Hampton Hall golf Facilities and equipment plus an evening dinner for the participants of the charity event. Additional expenses include \$1,885 for a volunteer appreciation event, \$1,737 in insurance costs, \$1,272 for golf balls for the 144 golfing participants and 15 wounded heroes, \$787 in auction expenses, \$452 in credit card fees, and \$419 for event signage. These items account for 92% of the total expenses shown on line 16.

Part III - The purpose of the Lowcountry Foundation for Wounded Military Heroes is to provide funds that directly support wounded warriors through charitable organizations like the Birdies for the Brave, part of the PGA Tour Charities, Inc FEIN 59-2774423, a 501-c-3 organization. These programs are designed specifically for the individual needs of wounded warriors and their families as they assimilate back into the into the civillian population. Beneficiaries will include service members in the US Navy, US Army, US Marines, US Airforce and US Coast Guard. The Foundation's goal is to raise these funds via a Golf Tournament to be held at the Hampton Hall Golf Course on an annual basis.
