Time Vault Storage is a not for profit organization 502-(c)(3) dedicated to permanent preservation using inert gas storage in a hermetically sealed enclosure (moisture within the envelope is eliminated or controlled). This controlled environment eliminates mold, infestations, yellowing and breakdown through oxidation. A number of items ranging from fabrics, manuscripts, paintings and seeds remain stable in this controlled inert gas environment. The technology and equipment for inert gas storage has been leased/licensed from Preservation Science and Technology, Inc for a fee of \$1

Time Vault Storage offers inert gas preservation services to the listed groups at cost or at no charge. These groups include

(1) Veteran's families for the preservation of a casket flag

(2) Libraries, museums, historical societies, seed exchanges and other non-profits which have a need for long-term preservation of collections

(3) Individuals may receive the benefit of preservation in the case of heirloom seeds or collections in need of preservation. In these cases the individual will need to cover the costs of supplies, labor and shipping.

Going forward we, will seek grants from foundations to cover the costs associated with inert gas preservation. Because we are small, a fee will need to be paid for materials, display costs, labor, shipping/handling.

This year we preserved 2 packages of heirloom seeds. We did not preserve any flags, but may do so again in another year.

The costs associated with organizations or individuals will vary upon their preservation and collection requirements.

At some point, we will need to process credit cards, but at this time we only deal with checks.

The budget for Time Vault Storage is small. We have received individual donations in the amount of \$10.00. The license/lease fee for equipment is an amount of \$1.00. We currently have some supplies on hand that were previously purchased. Time Vault Storage has a checking account.

Time Vault Storage does not expect our revenues to exceed \$10,000 per year. Time Vault Storage works from a shop attached to a residence that is appropriately zoned for this type of work in Adel, IA. There are no costs for the use of the location.
