

ARTICLE I
AMENDMENT

- Section 1: The name of the Corporation is The Greater Indianapolis Chamber of Commerce Foundation, Inc.
- Section 2: The date of incorporation of the Corporation is March 28, 1955.
- Section 3: The name of the Corporation following this amendment is The Greater Indianapolis Chamber of Commerce Foundation, Inc.
- Section 4: The exact text of the Second Amended and Restated Articles of Incorporation of the Corporation is attached hereto as Exhibit A.

EXHIBIT A

SECOND AMENDED AND RESTATED
ARTICLES OF INCORPORATION
OF
THE GREATER INDIANAPOLIS CHAMBER OF COMMERCE FOUNDATION, INC.

The Greater Indiana Chamber of Commerce Foundation, Inc. (the "Corporation"), having accepted the provisions of the Indiana Nonprofit Corporation Act of 1991, as amended (the "Act"), hereby sets forth its Second Amended and Restated Articles of Incorporation ("Articles of Incorporation") as follows:

ARTICLE 1

Name

Section 1.01. Name. The name of the Corporation is The Greater Indianapolis Chamber of Commerce Foundation, Inc

ARTICLE 2

Purposes and Powers

Section 2.01. Type of Corporation. The Corporation is a public benefit corporation.

Section 2.02. Primary Purposes. The purposes for which the Corporation is organized are limited as follows:

Clause 2.02(a). Primary Purposes. The Corporation is formed to encourage, aid or promote those educational or charitable organizations, endeavors or activities (specifically including, but not limited to, direct charitable activities, internships, scholarships, educational seminars and classes, distributions and grants) in the greater Indianapolis metropolitan area and the whole of the State of Indiana in order to further the charitable and educational purposes of the Greater Indianapolis Chamber of Commerce, (hereinafter referred to as either the "Supported Organization" or "GICC") an Indiana nonprofit corporation that is exempt from federal income tax under Section 501(c)(6) of the Internal Revenue Code of 1986, as amended, or the corresponding provisions of any future United States internal revenue law (the "Code").

The Corporation is formed as a supporting organization (as that term is defined in Section 509(a)(3) of the Code) and is organized and shall be operated exclusively for the benefit of, to perform the functions of, or to carry out the purposes of its Supported Organization. If the organization specifically named in this Clause (a) cannot act as a Supported Organization under Section 509(a)(3) of the Code, it shall cease to be the Supported Organization and the Board of Directors shall either select another Supported Organization or elect to dissolve the Corporation.

Clause 2.02(b). **Additional Purposes.** In addition, the Corporation is formed for the purpose of assisting and engaging in all activities that serve educational, charitable or scientific purposes, that are permitted by the Act, and that are permitted to be carried on by an organization exempt from Federal taxation under the provisions of Section 501(c)(3) of the Code or by an organization contributions to which are deductible under Section 170(c)(2) of the Code; provided, however, that the Corporation shall not engage in any activity unless it is for the benefit of; to perform the function of; or to carry out the exempt purpose of its Supported Organization.

Clause 2.02(c). **Limitations.** Nothing contained in these Articles of Incorporation shall be construed to authorize the Corporation to (1) engage in any activities or perform any functions that are not permitted by Section 501(c)(3) of the Code or (2) engage in any activity unless it is for the benefit of, to perform the function of, or to carry out the exempt purpose of its Supported Organization.

Section 2.03. Limitations Upon Powers. No part of the net earnings of the Corporation shall inure to the benefit of any Director or Officer of the Corporation or to any private individual, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered by a Director, Officer or employee. No substantial part of the activities of the Corporation shall consist of attempting to propose, support, oppose, advocate the adoption or rejection of, or otherwise influence legislation by propaganda or otherwise, and the Corporation shall not participate in or intervene in (including the publication or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these Articles, the Corporation shall not conduct or carry on any activities not permitted to be conducted or carried on by an organization exempt from Federal taxation under Section 501(c)(3) of the Code or by an organization contributions to which are deductible under Section 170(c)(2) of the Code. The Corporation shall not knowingly engage in any transaction that is an "excess benefit transaction" subject to excise tax under Section 4958 of the Code.

ARTICLE 3

Members

Section 3.01. Membership. The Corporation shall not have members.

ARTICLE 4

Provisions for Regulation of Business and Conduct of Affairs of the Corporation

Section 4.01. Management of Corporation. The affairs of the Corporation shall be managed by the Board of Directors of the Corporation.

Section 4.02. Number, Term and Appointment of Directors. The exact number of members of the Board of Directors shall be prescribed from time to time according to the By-Laws of the Corporation; provided, however, that under no circumstances shall the minimum number of members of the Board of Directors be less than three (3). In the absence of such a By-Law provision, the number of directors shall be eight (8). The Corporation's Board of Directors shall be appointed annually by the Board of Directors of GICC. Members of the Corporation's Board of Directors shall serve for a term of one (1) year and until their successors are duly elected and qualified or until their earlier resignation, death or removal from office.

Section 4.03. Limitation on Powers of the Board of Directors. Notwithstanding any contrary provisions in these Articles of Incorporation, the Board of Directors shall not have the power or authority to take or authorize any action that shall deprive the Corporation of its status as an exempt organization under the provisions of Section 501(c)(3) of the Code.

ARTICLE 5

Dissolution

Section 5.01. Dissolution. In the event of dissolution of the Corporation, assets remaining after payment of all debts of the Corporation shall be transferred by the Board of Directors to the United States, the State of Indiana, the City of Indianapolis, or any instrumentality or subdivision thereof, or to any nonprofit corporation, trust, foundation or other organization whose purposes are substantially the same as those of the Corporation and which, at the time of transfer, is exempt from Federal income taxation under Section 501(c)(3) of the Code; provided, however, that any transfer to a governmental entity shall be for exclusively public purposes. Any such assets not so transferred by the Board of Directors shall be disposed of by the Circuit Court of the County in which the registered office of the Corporation is located, exclusively for such tax-exempt purposes or to such tax-exempt organizations as the Court shall determine. No Director or Officer of the Corporation, or any private individual, shall be entitled to share in the distribution of any of the assets of the Corporation on dissolution of the Corporation.

ARTICLE 6

Restrictions Applicable If the Corporation Is Or Becomes A Private Foundation

Section 6.01. Restrictions. Notwithstanding anything contained in the Articles of Incorporation to the contrary, in the event and if for any reason the Corporation should fail to qualify as a "public charity" and is classified as a "private foundation" as that term is defined in Section 509(a) of the Code, then and in such event and in order to comply with Section 508(e) of the Code, and for so long as the Corporation may be deemed to be a "private foundation," the powers and activities of the Corporation in accomplishing the foregoing purposes shall be specifically subject to the following requirements, restrictions and limitations:

Clause 6.01(a). The Corporation shall not engage in any act of self-dealing as defined in Section 4941(d) of the Code;

Clause 6.01(b). The Corporation shall distribute its income for each taxable year at such time and in such manner as not to become subject to the tax on undistributed income imposed by Section 4942 of the Code;

Clause 6.01(c). The Corporation shall not retain any excess business holdings as defined in Section 4943(c) of the Code;

Clause 6.01(d). The Corporation shall not make any investments in such manner as to subject to tax under Section 4944 of the Code; and

Clause 6.01(e). The Corporation shall not make any taxable expenditures as defined in Section 4945(d) of the Code.

ARTICLE 7

Provisions for Regulation and Conduct of the Affairs of Corporation

In addition to the By-Laws and consistent with the Act, the following provisions for the regulation and conduct of the affairs of the Corporation, and for the creation, definition, limitation or regulation of the powers of the Corporation and its directors, shall apply:

Section 7.01. Committees. The Board of Directors may utilize one (1) or more committees, as set forth in the By-Laws to assist it in the carrying out of any of the purposes of the Corporation, define the responsibilities of such committee or committees and delegate to such committee or committees' powers as the Board of Directors determines to be appropriate.

Section 7.02. Amendment of Articles of Incorporation. The Corporation reserves the right to amend, alter, change or repeal any provisions contained in these Articles of Incorporation or any amendment hereto, by a majority vote of the members of the Board of Directors; provided, however, that no corporate action purporting to amend Article IV, Section 4.02 to eliminate the authority of the Board of Directors of GICC to appoint the Board of Directors of the Corporation shall be effective unless that action is approved and adopted, in writing, by at least seventy-five percent (75%) of the then-existing members of the Board of Directors of GICC, and such power of amendment shall not authorize any amendment which would have the effect of disqualifying the Corporation as a tax-exempt organization under the provisions of Section 501(c)(3) of the Code or would have the effect of disqualifying contributions to the Corporation for deduction under Section 170(c)(2) of the Code.

Section 7.03. Adoption and Amendment of By-Laws. The Corporation reserves the right to make, amend, alter, change or repeal any provisions contained in the By-Laws of the Corporation or in any amendment thereto, by a majority vote of the members of the Board of Directors; provided, however, that no corporate action purporting to eliminate the authority of the Board of Directors of GICC to appoint the Board of Directors of the Corporation shall be effective unless that action is approved and adopted, in writing, by at least seventy-five percent (75%) of the then-existing members of the Board of Directors of GICC, and such power shall not authorize any amendment, alteration, change or repeal which would have the effect of disqualifying the Corporation as a tax-exempt organization under Section 501(c)(3) of the Code or would have the effect of disqualifying contributions to the Corporation for deduction under Section 170(c)(2) of the Code.
