EDUCATION. DURING 2013, THE COLLEGE SPONSORED 4 POSTGRADUATE MEDICAL EDUCATION COURSES INCURRING \$318,000 IN EXPENSES TO SUPPORT THESE CRITICAL EDUCATIONAL COURSE NEEDS. IN ADDITION, THE ANNUAL CLINICAL MEETING HELD IN NEW ORLEANS, LA OVER A SIX-DAY PERIOD PROVIDED THE STRUCTURE FOR OVER 90 DIFFERENT COURSES, SEMINARS, AND LECTURES, WHICH WERE ATTENDED BY APPROXIMATELY 3,000 HEALTH CARE PRACTITIONERS. THE ANNUAL CLINICAL MEETING REQUIRED APPROXIMATELY \$3.0 MILLION IN EXPENDITURES TO ENSURE ALL FACETS OF THE CONFERENCE REMAINED SUCCESSFUL. THE EDUCATION DIVISION WAS ALSO ACTIVE IN THE DEVELOPMENT OF NEW EDUCATIONAL OFFERINGS (WHETHER IN TEXT, PAMPHLET, OR CD-ROM FORMAT) GEARED NOT ONLY TO THE PRACTICING PHYSICIAN BUT ALSO TO THEIR PATIENTS. IN ADDITION, THE COLLEGE INCURRED OVER \$708,000 IN SUPPORTING RESIDENT EDUCATION/PROGRAMS FOR PHYSICIANS SPECIALIZING IN THE PRACTICE OF OB/GYN.

MEMBER SERVICE PROGRAMMATIC EXPENDITURES. THESE EXPENDITURES ENSURE THE COLLEGE ADDRESSES AND SATISFIES THE MANY DIVERGENT NEEDS OF OUR MEMBERSHIP. THE 2013 EXPENSE TOTALS INCLUDE SUPPORT FOR COLLEGE-WIDE COMMUNICATION EFFORTS TO OUR MEMBERS (OUR MEMBERS HAVE ACCESS TO THE MENOPAUSE MAGAZINE "PAUSE" AT NO CHARGE AND THE MONTHLY "NEWSLETTER"), THE RESOURCE CENTER WHICH MAINTAINS EXTENSIVE INFORMATION ON WOMEN'S HEALTH ISSUES AVAILABLE TO OUR MEMBERS AND THE GENERAL PUBLIC, AND SUPPORT FOR ELECTRONIC DISSEMINATION OF INFORMATION THROUGH THE MEMBER'S WEBSITE, AND THE EDITORIAL FUNCTIONS EXERCISED OVER THE MANY PATIENT EDUCATION LITERATURE.

PUBLICATIONS, PRACTICE AND HEALTH SERVICES. THE COLLEGE MAINTAINS, DEVELOPS, AND REVISES UP-TO-DATE AND COMPREHENSIVE PROFESSIONAL PUBLICATIONS GEARED TO SATISFY THE INFORMATIONAL NEEDS OF BOTH THE WOMEN'S HEALTH CARE PROFESSIONALS AND THEIR PATIENTS. OVER 700 TITLES ARE MAINTAINED IN THE COLLEGE'S INVENTORY AND ARE MADE AVAILABLE TO HEALTH CARE PROFESSIONALS AND INSTITUTIONS THROUGHOUT THE WORLD. DURING 2013, APPROXIMATELY 93,000 ORDERS FOR PUBLICATIONS WERE RECEIVED, PROCESSED AND SHIPPED. IN 2002, THE COLLEGE INTRODUCED THE CLINICAL UPDATES IN WOMEN'S HEALTHCARE MONOGRAPH SERIES ADDRESSING TOPICS OF CURRENT INTEREST TO THE PRACTICING PHYSICIAN. THIS SERIES HAS PROVEN TO BE VERY POPULAR WITH HEALTHCARE PROFESSIONALS. IN 2013, APPROXIMATELY 11,700 SUBSCRIPTIONS WERE FILLED. PRACTICE SERVICE EXPENDITURES PROMOTED THE DEVELOPMENT, PROMULGATION AND DISSEMINATION OF STANDARDS OF CARE FOR WOMEN'S HEALTH. THE COLLEGE SPENT OVER \$247,000 IN SUPPORT OF COMMITTEES SUCH AS GYNECOLOGIC PRACTICE, THE OBSTETRICAL PRACTICE, ETHICS, PATIENT SAFETY, AND GENETICS. THE COLLEGE ALSO CONTINUED ITS LIAISON EFFORTS WITH THE AMERICAN ACADEMY OF PEDIATRICIANS AND THE ACADEMY OF FAMILY PRACTITIONERS TO ENSURE CLINICAL CARE STANDARDS DEVELOPED FOR THE MEDICAL SPECIALTIES WERE APPROPRIATELY COORDINATED AND CONSISTENT. DURING 2013, THE COLLEGE'S COMMITMENT TO ISSUES AFFECTING WOMEN'S HEALTH WAS DEMONSTRATED THROUGH THE EFFORTS ASSOCIATED WITH THE PROMOTION OF SEVERAL INITIATIVES. THE COLLEGE SUPPORTED OUTREACH PROGRAMS TO UNDERSERVED WOMEN AND ADOLESCENTS, PROMOTED SMOKING CESSATION PROGRAMS, DEVELOPED INITIATIVES TO BETTER EDUCATE PROFESSIONALS ON DOMESTIC VIOLENCE ISSUES, AND UNDERTOOK INITIATIVES IN CENTRAL, SOUTH AMERICA AND AFRICA TO PROMOTE WOMEN'S HEALTH IN THESE UNDERSERVED AREAS. IN ADDITION, THE COLLEGE PRODUCED "HOW I PRACTICE MEDICINE" VIDEOS TO ASSIST MEMBERS IN MEETING THE MANY DIVERGENT ASPECTS OF PROVIDING MEDICAL CARE. THE COLLEGE SPENT ALMOST \$3.0 MILLION IN PRODUCING AND DISSEMINATING THE PREEMINENT SCIENTIFIC JOURNAL FOR THE PRACTICE OF OBSTETRIC AND GYNECOLOGY.

RESEARCH. DURING 2013, THE COLLEGE PROVIDED THE ADMINISTRATIVE OVERSIGHT AND GUIDANCE TO FEDERALLY FUNDED AND FOUNDATION-SUPPORTED GRANTS AND CONTRACTS PROMOTING RESEARCH FOR WOMEN'S HEALTH. THE COLLEGE HAS ASSUMED A LEADING ROLE IN MANY RESEARCH PROJECTS AND STUDIES DIRECTLY IMPACTING WOMEN'S HEALTH. THE NATIONAL INFANT MORTALITY REVIEW PROJECT, WHICH PROVIDES A NATIONAL SYSTEM OF COMMUNITY-BASED FETAL AND INFANT MORTALITY REVIEW ACTIVITIES, NOW SERVES AS A RESOURCE CENTER FOR OVER 200 PROJECTS IN 40 STATES. COLLEGE EXPENDITURES APPROXIMATED \$313,000 IN 2013. ANOTHER PROJECT ADDRESSED EFFORTS TO REDUCE PERINATAL TRANSMISSION OF HIV BY DEVELOPING AND BROADLY DISSEMINATING MATERIALS ON PERINATAL HIV COUNSELING, TESTING, AND TREATMENT. APPROXIMATELY \$40,000 WAS SPENT IN 2013 FOR THIS PROJECT. OTHER PROJECTS IN 2013 ADDRESSED IMMUNIZATION PROTOCOLS, DIABETES IN WOMEN AND WORKSHOPS TO IMPROVE THE DELIVERY OF HEALTHCARE TO INDIANS.
