MGS held its 37th consecutive annual conference involving practitioners and researchers from a variety of disciplines, including health and human service providers, academics, researchers and older adults. The theme was "Re-thinking Accountability and Outcomes in the New Era of Healthcare", keynote by Nancy Rehkamp, Director of Health Care Innovation at CliftonLarsonAllen. The conference featured 10 educational sessions led by experts throughout the state, 9 poster and exchange sessions, and 19 exhibits by Minnesota organizations. The annual Gerontologist of the Year award was presented, along with two scholarships awarded to higher education students majoring in a gerontology related field in Minnesota. This conference allows practitioners, researchers, faculty and students to gain information on evidenced-based services to seniors, to learn about relevant research that improve results, and to highlight new services that meet emerging and critical issues. Attendees receive continuing education credits for their participation in the conference.

Education is a primary focus of MGS. To fulfill this mission, eight state-wide webinars were held. Topics are selected by a committee of gerontologists and aging service professionals and included: Helping Older Adults Sleep Better - Linda Shell, VOA; A Holistic Approach to Dementia Care & Validation - Diane Knettel, VOA; Fall Prevention - David Fink, MAAA; Research-Practice Validation - Catherine Sullivan, St. Catherine University; Health Care Directives & Ethical Wills - Pat Schommer, UMN Center on Aging; Long Term Care - Robert Kane, UMN Center on Aging; and Evidence Based Health Care Programs - Mary Hertel, CMCOA. Feedback from participants indicated that the information and resources in the webinars was used to improve services and to train volunteers and staff about the issues involved in providing effective services to older adults. Over 525 people attended the webinars. Attendees are eligible to receive continuing education credits. In addition, information was shared through a bi-monthly newsletter, email alerts and on the MGS website at www.mnagero.org.
