THE SOCIETY FOR BASIC UROLOGIC RESEARCH (SBUR) IS A SOCIETY OF SCIENTISTS WHOSE EXPERTISE INCLUDES THE STUDY OF UROLOGIC CANCERS (PROSTATE, BLADDER, KIDNEY, TESTIS, PENIS), THE BIOLOGY OF PROSTATE GROWTH, KIDNEY AND BLADDER FUNCTION, AUTOIMMUNE UROLOGIC DISEASES, INFECTIOUS DISEASES, NEURO-UROLOGIC DISEASES, MALE REPRODUCTIVE BIOLOGY, INFERTILITY AND ERECTILE DYSFUNCTION. MEMBERS INCLUDE MOLECULAR BIOLOGISTS, IMMUNOLOGISTS, EPIDEMIOLOGISTS, ONCOLOGISTS, BIOCHEMISTS AND CLINICAL UROLOGIC SCIENTISTS.
