IFF is a nonprofit organization that offers lending, facilities planning, real estate development and research services to Midwest nonprofits serving disadvantaged populations. IFF services help nonprofits complete their real estate-related projects and strengthen their financial, operational and management capacity to meet their missions. IFF works with nonprofits, government agencies, and philanthropic stakeholders to deliver innovative solutions to underserved communities and to help achieve their community development goals.

Capital Solutions. This program makes below market loans to nonprofit agencies. Since 1990, the total loan volume reached \$456 million which includes 1,114 loans closed that have resulted in total cost savings of \$24.3 million for clients. Since 1990, these loans have assisted with the renovation or construction of 14.4 million square feet and created 5,080 child care slots, 36,586 student seats, 197,508 new patients/visits at health care clinics, 5,752 affordable and supportive/special needs housing units, and 1,327 beds. In addition, the loans have helped to employ 54,795 full time equivalents. IFF’s financing has leveraged over \$1.4 billion in capital.

Community Strategies Initiative. IFF has worked to strengthen nonprofits and their communities through expertise in finance, real estate planning and development, and research. IFF will work with local and state government, nonprofit agencies, foundations and other community groups to help achieve their community development goals by assessing community conditions through analysis of demographic data and trends, inventorying existing community assets and identifying gaps, evaluating housing, human services, education, health care, investments and job environments, and providing a community conditions analysis to guide work with stakeholders in developing strategic plans and prioritizing investments. IFF will develop solutions with conceptual projects and programs with strategic partners and will facilitate community partnership by bringing together relevant parties. Through this work, IFF will continue to address a broad range of community needs - from health care, education, and housing to child care, healthy food access and job training.

Real Estate Services Program. This program helps nonprofits make better real estate and space decisions to support growth planning, program changes, and financial and organizational capacity. The goals and objectives of each nonprofit client determine IFF’s scope of consulting services, from advising on real estate strategies to solving specific need for additional or new space. Clients choose from a comprehensive menu of fully integrated services based on a proposal tailored to specific needs, all at below-market fees. Services provided include feasibility assessments, facility assessments, strategic facilities plans, site search and due diligence, and owner’s representative services. Since 1997, 610 projects have been worked on in this program and has resulted in a total cost savings for clients of \$18.3 million and has funded the renovation or construction of 1.9 million square feet. In addition, this program has created 4,069 child care slots, 6,480 charter school seats, 61,296 new patients/visits at health care clinics, and developed 140 housing units and 70 beds.

Public Policy and Communications. IFF’s public policy and communications department advances IFF’s priorities in the areas of community development finance, the nonprofit sector, charter schools, early care and education, health care and housing. It also supports the growth of IFF in the Midwest.
