mathematics. These grants are used for material costs to implement their
desired math program. The Foundation develops math curriculum, for all
learning levels, for teachers' use in the classroom as stand-alone curriculum or
to supplement the textbooks provided. The curriculum is provided to teachers and
their students at no cost to them. Curriculum developed and disseminated annually
reaches over 150,000 teachers, impacting millions of students.

creates and disseminates a Financial Smarts newsletter at no cost to the consumer.
