

In-Prison Ministries: In 2013, KHNM conducted 14 Freedom God's Way events in 14 Illinois correction centers (13 male facilities and 1 female facility). These weekends focus on presenting the Gospel of Jesus Christ and preparing inmates for their return to society. Expense includes costs of Bibles and books distributed, communion elements, and travel. In September, a special Freedom God's Way was held for 8 inmates from the Segregation Unit at Pontiac Correctional Center. The KHNM team also conducted 11 Sunday worship services or special one-day events at 3 Illinois correction centers and 6 out-of-state facilities (LA, MN, SD, and TN). At the request of the IL Department of Corrections, KHNM team members participated in a Re-entry Summit at Pontiac Correctional Center.

Meet Me at the Gate (MMATG) KHNM facilitates the integration of former inmates into the church, workplace, and society through a number of means, from helping specific individuals to working with family members, churches and employers. In 2013, the main ministry vehicle was a weekly dinner and Bible study called Radical Time Out (RTO). From an average attendance of 11 for January & February, RTO grew to an average attendance of 70 by December. In addition, KHNM acted as a consultant for four churches and para-church groups involved in post-prison ministry.

Koinonia House of DuPage County, Inc., d/b/a Koinonia House of Wheaton Although the residential portion of this ministry was suspended in 2012, KHNM continued to mentor and disciple former inmates, helping with biblical discipleship, housing, transportation and employment needs on a case-by-case basis. Significant time was devoted to working with 10 individuals in 2013.
