The Organization provides housing, supportive services, and community outreach to help homeless and at-risk veterans and their families achieve self-sufficiency. From its two facilities in Wheaton, Illinois, the Organization successfully transitioned 15 of 16 veterans, meaning the individuals were employed, sober and moving into permanent housing upon discharge. The Organization also housed 11 veterans in their Affordable Housing Program and assisted 127 families and 68 individuals with supplies, services and referrals through their community outreach efforts.

The Organization assisted 49 households, 112 individuals, with housing and support services through their Supportive Services for Veteran Families program. This program provides services to low-income homeless and at-risk veteran families living in or transitioning to permanent housing in DuPage, Grundy, Kane, Kendall, Will, DeKalb and LaSalle counties, including services that promote housing stability and play a key role in connecting veterans and their family members to VA services such as mental health care and other benefits. Under the program the Organization also offers financial assistance to veterans for rent, utility and security deposit payments.
