Wildlife Guardians is a charitable organization whose mission is to help promote the survival and well-being of the lion and other imperilled African wildlife species.

\$270,000 Grant to Lion Guardians: Provided financial support to Lion Guardians whose work contributes to Wildlife Guardians' objectives of protecting lions in East Africa. Lion Guardians is a nonprofit limited liability corporation in Kenya working to conserve lions in southern Kenya and northern Tanzania by recruiting young non-literate Maasai warriors to become actively engaged in protecting lions rather than killing them. Lion Guardians monitors lion movements, warn pastoralists when lions are in the area, recover livestock, reinforce protecting livestock fencing, and intervene to stop lion hunting parties. Collectively, these efforts lead to a reduction in the loss of livestock, which in turn enhances the livelihoods of the local people and builds tolerance for lions and other carnivores. With funding from Wildlife Guardians, Lion Guardians has greatly expanded the areas where lions are protected, including new areas of Tanzania.

Grant to Niassa Carnivore Project: For the second year in a row, Wildlife Guardians awarded a grant to the Niassa Carnivore Project, whose works contributes to Wildlife Guardians' objectives of protecting lions in East Africa. This grant was used to promote lion conservation in Mozambique by reducing the number of lions killed in illegal bush-meat snares in the Niassa National Reserve.

Wildlife Guardian makes grants to support charitable and educational projects that are conducted by a nonprofit wildlife conservation called Lion Guardians and other similar groups in Kenya and Tanzania. Before making any grants, WG's Board of Directors conducts a pre-grant inquiry to ensure that the proposed grantee (whether Lion Guardians or another organization) will use WG funds in a manner that that exclusively furthers WG's charitable and educational purposes. These inquiries focus on the identity, prior financial and programmatic history, and experience of the potential grantee and its managers. WG does not make any grants to an organization until it is satisfied that the grantee intends to use and is capable of using the funds in the manner required. WG ensures that it receives and maintains full and complete annual reports from each grantee on the use of grant funds, the grantee's compliance with the terms of the grant agreement, and the progress made by the grantee toward achieving the purposes for which each grant is made.

Grantees are selected by WG's Board of Directors, excluding anyone on the Board who would derive any financial benefit from the grant. Currently, there are two individuals on the Board who would be required to recuse themselves from any decisions to fund projects of Lion Guardians: Leela Hazzah and Stephanie Dolrenry. Neither participate in any decisions concerning the granting of funds to Lion Guardians. WG does not maintain a program outside of the United States; however, its directors and officers have on occasion travelled to Africa to observe how WG grants are being used by grantees. In addition, because two of WG's directors (Hazzah and Dolrenry) are based in Kenya and as fiduciaries of WG, they are able to ensure that any funds granted by WG to Lion Guardians are used exclusively for the charitable and educational purposes for which the grants are made.

WG maintains all of documentation, in addition to all records developed as part of the pre-grant inquiry, including approved proposals, and all recorded decisions of the Board of Directors with respect to such grants, for a period of no less than 10 years after the termination of any grant. All of these records are maintained with WG's permanent records. WG makes grants only pursuant to written grant agreements that specify the parties' responsibilities, obligate the grantee to use the grant funds only for the purposes for which the grant was made, and require periodic written financial and narrative reports concerning the use of the grant funds. All of our agreements ensure that WG maintains discretion and control over its resources by clearly stating that WG has the authority to withhold and/or recover grant funds in cases where such funds are misused. Potential grantees will be required to sign these agreements before any funds are released.

Recipients of grant funds are required to provide detailed interim and final reports that comprehensively detail the use of WG funds. Any recipient may also be subjected to visits by Wildlife Guardian representatives to monitor the use of funds. In the case of very large grants or where there are questions about a grantee's financial reporting, the WG Board of Directors may also require an independent audit conducted of a grantee's use of WG grant funds.
