The primary mission of the organization is to provide grants to public school educators in our community's two school districts.

Teachers go through a rigorous application process in which completed applications are submitted "blind" to the grants committee.

We take great care to make sure neither the applicant's name nor school is known during the grant review process. In 2013, grant applications received exceeded budgeted grant amounts by several thousand dollars. The grants committee carefully reviews each application to determine those that are worthy of funds from the budgeted funds. Applicants awarded funds use the money to underwrite innovative teaching projects.
