Hanson Foundation provided \$1250, \$1250, and \$2000 respectively for the concerts to provide partial funding for the artists, miscellaneous costs, and promotion of the events. These events were free to the public with free-will donations accepted. Many patrons simply throw out a blanket and listened from various areas in the park. As such, there is no means to provide an accurate attendance. Concert #1 was on June 29 featuring a popular western swing band. Attendance was approximately 300. Concert #2 was on July 20 featuring a regional blues band. Attendance was approximately 300. Concert #3 was on August 24 featuring a salsa band from Cedar Falls.
