The Ark is located in Kalamazoo and is the only short-term crisis intervention shelter serving youth ages 10-17 in the nine counties served by the Diocese of Kalamazoo. The Ark serves youth who have run away; are in danger of being homeless; or are experiencing a crisis. Youth stay up to 21 days and receive counseling, support services, and aftercare services at no charge. The goal is to unite and strengthen families. In 2013, the Ark shelter served 238 runaway and homeless youth and provided 2,798 days of care. The Ark Community Services program helps homeless youth ages 16-21 to find housing, complete their education, and find employment. In 2013, they provided 1982 hours of counseling and case management services and 5256 days of housing assistance to 36 youth. The Ark Outreach program helps homeless youth on the streets; offers free education and prevention workshops in schools and other organizations and helps to promote the Ark services. In 2013, staff made 172 presentations, and provided 378 hours of crisis intervention services to 860 youth. Through community support, assistance in the form of household items valued at \$3,873, were distributed to eligible youth served through these programs.

Caring Network serves pregnant and parenting young women and their families in Kalamazoo County. The goals are to ensure healthy pregnancies and babies and to help develop healthy parenting behaviors. Services are provided at no charge to clients and include case management; in-home visits; referrals; pregnancy and parenting classes; postpartum depression screening; infant mortality screening and education; family literacy programs; material items; adoption counseling and transitional housing. In 2013, Caring Network provided 1112 sessions of case management to 41 women; provided prevention and support services to 502 women; plus briefly assisted 10 additional women. 4 adults and 3 babies spent a total of 329 days of residence in the Caring Network apartments. 45 Post adoption contacts were made and 4 cases were opened. Caring Network also provides supportive in-home services to families in Kalamazoo, Cass and St. Joseph counties, through a partnership with the State of Michigan Department of Human Services. Through community support, assistance in the form of clothing, furniture, household items, car seats, cribs, diapers, and holiday gift baskets valued at \$65,085 were given to eligible clients.

The Bridges program provides high quality outpatient mental health counseling for individuals, couples, families and children. Bridges helps clients resolve issues relating to depression; anger management; marital or relationship conflicts; grief, loss, gender identity and other life transitions, to improve their quality of life. In 2013, Bridges counseling provided 8 group therapy sessions for adolescent girls referred to us through other community agencies and helped them to resolve depression and anger management issues. Bridges served a total of 448 clients, providing 1851 therapy sessions. Bridges accepts many insurances, including Medicaid and Medicare and serves many non-insured and low income clients.

This monitoring included monthly review of statistical, outcome, and financial data through agency management teams and quarterly review by the Board of Directors. All requests for client assistance require specific documentation, including the client number, to track expenditures to specific grants and client case files and the program supervisor's approval. The Finance Director reviews and approves all expenditures based on funding levels and compliance with grant budgets. the agency also complies with all requests for audits and reviews by funding bodies and has had no significant compliance findings in 2013; ensuring appropriate use of these funds. Each program also provides training to direct service, management, and administrative staff on proper service delivery and budget compliance issues, reviewing requirements and specific grant/contractual obligations frequently. Staff are required to attend trainings and technical assistance sessions sponsored by grantors to ensure they are aware of the latest contractual information and best practices of implementation whenever offered.

Part III. The number of housing and utilities assistance recipients has been determined by the number of program participants, which is verified through grant reporting. Other categories of assistance are tracked through client numbers by category and estimates are made in the transportation category based on the number of clients served in each program.
