DELTA DENTAL FUND'S PURPOSE IS PROMOTING DENTAL EDUCATION AND RESEARCH, ADVANCING DENTAL SCIENCE, AND PROMOTING ORAL HEALTH OF THE PUBLIC BY PROVIDING FUNDS FOR CHARITABLE PROJECTS DELTA DENTAL FUND HAS BEEN COMMITTED TO THIS PURPOSE FOR OVER TWO DECADES OVER THAT TIME, THOUSANDS HAVE BENEFITED FROM GRANTS AND SCHOLARSHIPS THE FUND HAS PROVIDED SINCE THE FOUNDATION WAS ESTABLISHED IN 1980, WE HAVE CONTINUALLY INCREASED OUR EFFORTS TO ACHIEVE THESE GOALS IN MICHIGAN, OHIO, INDIANA, AND NORTH CAROLINA SEE SCHEDULE O FOR CONTINUATIONSINCE 1980, THE INAUGURAL YEAR FOR THE FUND, MORE THAN 800 DENTAL STUDENTS HAVE BEEN SUPPORTED THROUGH THE SCHOLARSHIP PROGRAM AND STUDENT LEADERSHIP AWARDS AGAIN IN 2013, EIGHT STUDENTS FROM THREE DENTAL SCHOOLS IN MICHIGAN, OHIO, INDIANA AND NORTH CAROLINA, THE UNIVERSITY OF MICHIGAN, THE OHIO STATE UNIVERSITY, CASE WESTERN RESERVE UNIVERSITY, RECEIVED FINANCIAL GRANTS THROUGH THE FUND TO APPLY TOWARD THE COST OF EDUCATION DELTA DENTAL FUND HAS PROVIDED OVER \$1 MILLION IN SCHOLARSHIPS OVER THE PAST 30 YEARS IN ADDITION TO PROVIDING THESE SCHOLARSHIPS, THE DELTA DENTAL FUND ALSO CONTINUES TO RECOGNIZE FOURTH YEAR DENTAL STUDENTS FROM EACH DENTAL INDIANA, WE CONTINUED OUR SMALL GRANTS PROGRAM RENAMED AND RE-DESIGNED THIS YEAR, THE BRIGHTER FUTURES COMMUNITY GRANTS PROGRAM WILL AWARD \$200,000 WORTH OF SMALL GRANTS TO ORGANIZATIONS FOCUSED ON CHILDREN'S ORAL HEALTH AND \$75,000 TO PROGRAMS WITH AN ADULT FOCUS THIS YEAR ALSO MARKS THE THIRD YEAR OF OUR SMILES FOR KIDS GRANT PROGRAM IN NORTH CAROLINA WHICH FOCUSES EXCLUSIVELY ON CHILDREN'S ORAL HEALTH DURING 2013, THE FUND MADE ITS THIRD INSTALLMENT OF OUR THREE YEAR GRANT TOTALING \$450,000 FOR THE OPERATION OF THE MOBILE DENTAL COACH OPERATED BY THE OHIO STATE UNIVERSITY COLLEGE OF DENTISTRY THROUGH THE MOBILE COACH, COMPREHENSIVE DENTAL CARE IS PROVIDED TO THOUSANDS OF AT-RISK CHILDREN IN THE COLUMBUS, OHIO PUBLIC SCHOOLS SEPTEMBER MARKED A FIRST FOR THE FOUNDATION AND FOR THE STATE OF OHIO WHEN THE DELTA DENTAL CENTER AT OYLER SCHOOL OPENED ITS DOORS IN CINCINNATI THIS PAST SEPTEMBER THE FIRST SCHOOL-BASED CLINIC IN THE STATE AND THE FIRST IN THE TRISTATES TO HAVE THE DELTA DENTAL NAME, THIS CLINIC WILL PROVIDE CARE TO OVER 900 CHILDREN THIS YEAR IN A HIGH QUALITY, STATE-OF-THE ART FACILITY DELTA DENTAL FUND IS CONTRIBUTING OVER \$133,000 OVER A TWO-YEAR PERIOD FOR THIS PROGRAM IN MICHIGAN, WE AWARDED \$272,000 TO THE MICHIGAN DEPARTMENT OF COMMUNITY HEALTH TO SUPPORT THE SEAL MICHIGAN AND COMMUNITY WATER FLUORIDATION PROGRAMS IN ADDITION, PART OF THIS FUNDING WILL BE USED TO PILOT A SCHOOL-LINKED DENTAL SEALANT PROGRAM WHICH IS THE RESULT OF A PARTNERSHIP BETWEEN THE FOUNDATION, THE MICHIGAN DEPT OF COMMUNITY HEALTH, ACCESS AND THE SCHOOL-COMMUNITY HEALTH ALLIANCE OF MICHIGAN THIS ORAL HEALTH PARTNERSHIP IS THE FIRST OF ITS KIND IN THE STATE, AND IF IT IS SUCCESSFUL, IT COULD BE THE MODEL FOR OTHER SCHOOL-BASED AND SCHOOL-LINKED PROGRAMS IN INDIANA, WE CONTINUED OUR SUPPORT OF THE SEAL INDIANA PROGRAM WITH ANOTHER FIFTY THOUSAND DOLLAR GRANT, BRINGING TOTAL SUPPORT FOR THE PROGRAM TO MORE THAN \$300,000 THIS MOBILE DENTAL SEALANT PROGRAM, OPERATED BY THE INDIANA UNIVERSITY SCHOOL OF DENTISTRY, OFFERS PREVENTIVE SERVICES SUCH AS EXAMINATIONS, DENTAL SEALANTS AND FLUORIDE VARNISH TREATMENTS THE PROGRAM TRAVELS TO SCHOOLS, TREATING CHILDREN FROM LOW-INCOME FAMILIES WHO ARE NOT RECEIVING OR DO NOT HAVE ACCESS TO ROUTINE DENTAL CARE IT HAS MADE MORE THAN A THOUSAND VISITS TO INDIANA'S TITLE ONE SCHOOLS, TREATING CHILDREN FROM LOW-INCOME FAMILIES WHO ARE NOT RECEIVING OR DO NOT HAVE ACCESS TO ROUTINE DENTAL CARE THE FOUNDATION'S TOTAL GRANTS HAVE NOW EXCEEDED OVER SEVENTEEN MILLION DOLLARS SINCE ITS FORMATION THIS FUNDING HAS IMPROVED
