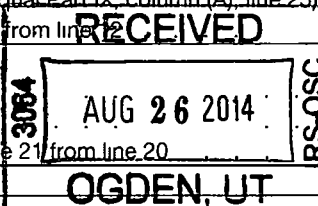

MSA supports payments to 213 UM registered/recognized student organizations, to fund student extracurricular activities and events. MSA operates its funding to student organizations through a reimbursement process. Registered UM student organizations must apply to MSA for funding events that directly affect the greater UM student/non-student community. All funding is awarded through a reimbursement process where UM student organizations are required to submit authentic proof of payment of applied for and awarded event expenses, and MSA verifies such expenses and reimburses the student organization with the awarded and approved expenses. MSA retains all student organization funding applications and expense proof of payments for up to 5 to 7 years.

4b (Code:) (Expenses \$ 162,320 including grants of \$) (Revenue \$ 130,684)

Airbus provided convenient, low-cost transportation for UM students and the UM community between the University of Michigan Ann Arbor campus and Detroit Metro Airport, during the four University breaks.

4c (Code) (Expenses \$ 97,195 including grants of \$) (Revenue \$ 97,195)

University of Michigan students are awarded stipends to assist with childcare expenses.

MSA is not allotted any funds/stipends directly for childcare expenses. Rather all such funds are directly allocated to the UM Financial Aid department. MSA understands the University of Michigan's Financial Aid Department uses the stipend allotment to assist University of Michigan students with childcare expenses as needed.

MSA understands that one dollar of all student fees are used for UM childcare, administered solely and directly by the UM Financial Aid Department.

organizations with a grant for approved expenses. MSA retains all student organization funding applications and proof of expenses up to 5 to 7 years.

All awarded funding is decided by a student funding body comprised of at least 10 to 30 students, including MSA elected representatives and UM students-at-large. All MSA awarded funding is reimbursed during the appropriate UM academic semester as the funding was applied for, and within the same academic year.

MSA does not fund any lobbying activities or political activities of registered/recognized student organizations at the University of Michigan.
