Our strategy is to reach, save, and disciple an entire unreached village, enabling them to become self-supporting in 2-4 years. We do this by using various methods of reaching villages and people for Christ: Medical camps, disaster relief, etc. Then we install a native pastor to live in a new area, install a water well and plant a church. With an installed native pastor we can then strengthen the village by providing food, clothing, medical training, educational supplies, literature, tapes, and Bibles. After we accomplish this, we then provide a vocational training center to help the village become self sustaining.
