NOTE A. NATURE OF ACTIVITIES AND SIGNIFICANT ACCOUNTING POLICIES

Organization and nature of activities

The North Woodward Community Foundation (the Foundation) was founded in 1997 as an autonomous, nonprofit, philanthropic organization that raises and manages a variety of endowment and non-endowed funds from donors who care about a specific community. The Foundation is qualified with the State of Michigan as a certified community foundation.

Basis of presentation

The Foundation's financial statements have been prepared on the accrual basis of accounting, which recognizes revenue and support when earned and expenses when incurred in accordance with accounting principles generally accepted in the United States of America.

Financial statement presentation follows requirements of the Not-for-Profit Entities Topic of the FASB Accounting Standards Codification. Net assets of the Foundation are classified as unrestricted, temporarily restricted, or permanently restricted. Contributions and income received by the Foundation are held in various funds which are classified as follows:

Unrestricted net assets - The Foundation reports contributions as unrestricted support. The bylaws of the Foundation and fiscal agreements include a variance provision, giving management the power to vary the use of funds in compliance with a restriction, if the restriction is unnecessary, undesirable or incapable of fulfillment, or is not consistent with the Foundation's goal of serving the needs of the communities it serves.

Temporarily restricted net assets - These consist of resources of which the use by the Foundation is limited by donor imposed stipulations that either expire by the passage of time or can be fulfilled and removed by actions of the Foundation pursuant to those stipulations. There were no temporarily restricted net assets as of December 31, 2013.

Permanently restricted net assets - consist of beneficial interest in perpetual trusts and funds created by donors which cannot be removed by actions of the Foundation. There were no permanently restricted net assets as of December 31, 2013.

Cash and cash equivalents

The Foundation considers all highly liquid investments with a maturity of three months or less to be cash equivalents. However, short-term investments with maturities at the date of purchase of three months or less, which are subject to investment management direction, are treated as investments rather than cash.

Contributed services

Individuals volunteer their time and perform a variety of tasks that assist the Foundation, but these services do not meet the criteria for recognition as contributed services, as required by the Not-for-Profit Entities Topic of the FASB Accounting Standards Codification. Accordingly, no amounts have been recognized in the financial statements.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities and the reported amounts of revenue and expenses. Actual results could differ from those estimates.

NOTE A. NATURE OF ACTIVITIES AND SIGNIFICANT ACCOUNTING POLICIES, continued

Property and equipment

Property and equipment are recorded at cost or, if donated, at the approximate fair value at the date of donation. Management's policy is to capitalize fixed assets that have a useful life of one year or more and a cost or donated value of \$1,000 or more. As of December 31, 2013, no property and equipment had been capitalized.

Investments

Investments in marketable securities with readily determinable fair values and all investments in debt securities are reported at their fair values in the statement of financial position. Unrealized gains and losses are included in the change in net assets.

Income taxes

The Foundation is a non-profit organization exempt from Federal income taxes under Section 501(c)(3) of the Internal Revenue Code. The Foundation is no longer subject to U.S. federal tax examinations for years before 2010.

Events occurring after reporting date

Management has evaluated events and transactions for potential recognition or disclosure through the date of the auditor's report, which is the date that the financial statements were available to be issued.

Investment Risks – Investment securities are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the values in the near term could materially affect the amounts reported in the accompanying financial statements.

NOTE C. CREDIT RISK

The Federal Deposit Insurance Corporation (FDIC) insures balances in one bank up to \$250,000. Money market funds at investment firms are not insured by the FDIC. The Foundation has balances in one bank that exceed the FDIC insured limit. The Foundation has not experienced any losses with respect to uninsured balances.

NOTE D. ADMINISTRATIVE ALLOCATION

The Foundation manages a variety of funds from donors of specific communities. A fiscal fee of 5% is charged to manage the funds.

NOTE E. FAIR VALUE MEASUREMENTS

Accounting standards require certain assets be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

In general, fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Foundation has the ability to access.

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, and other inputs such as interest rates and yield curves that are observable at commonly quoted intervals.

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset. These Level 3 fair value measurements are based primarily on management's own estimates using pricing models, discounted cash flow methodologies, or similar techniques taking into account the characteristics of the asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Foundation's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

As of December 31, 2013, all investments are classified as Level 1, in which valuation is based on quoted prices for identical instruments traded in active markets, such as the New York Stock Exchange, U.S. Treasury securities that are traded by dealers or brokers in active over-the-counter markets, and money market funds.

NOTE F. ENDOWMENT FUNDS

Endowment funds at December 31, 2013 were \$247,173.

Interpretation of Relevant Law

The Foundation is governed by the articles of incorporation and bylaws, which include a variance provision and powers of modification, which gives management the power to vary the use of funds if a restriction expressed by a donor would result in use contrary to the intent presumed.

The State of Michigan adopted the Uniform Prudent Management of Institutional Funds Act (UPMIFA) effective September 10, 2009. The Foundation's board of directors has determined that the Foundation's net assets do not meet the definition of endowment under UPMIFA, although the Foundation intends some of its funds to be permanent and manages them accordingly.

Endowment Investment Policies

The Foundation has adopted investment and spending policies for endowment assets with the intent to preserve the purchasing power of those assets. The basic investment standards are those of a prudent investor as articulated in applicable state laws. The primary objective is to preserve and protect its assets by earning a total return for each fund that is appropriate for its time horizon, distribution requirement, and risk tolerance.
