Grants are awarded which may be used for medical expenses, basic living expenses, or funeral expenses. Anyone who has worked at least five years full time in the industry, whether behind the curtain or behind the camera, or for one of the companies who manufacture or supply products and services to the industry, may apply for a grant. Since the first grant in 2006, over \$450,000 has been awarded to pay for the necessities such as rent/mortgage, utilities, medications, doctor visits, and health insurance premiums. Behind the Scenes bring help and hope to our colleagues in their darkest hours.
