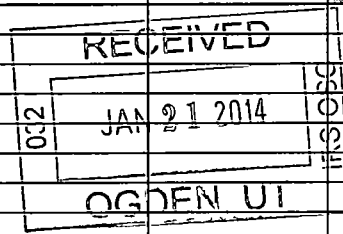

**BY-LAWS
CAPTIONS FOR LITERACY**

Name, Books, Records, and Fiscal Year

The name of this charitable trust is Captions for Literacy (the "Trust").

Correct and complete books of account and records of the Trust's activities and financial affairs shall be maintained at its principal office.

The fiscal year of the Trust shall end on December 31st.

Article I

Purpose

The specific charitable and educational purposes of the Trust are as set forth in the Trust Agreement, and are to be conducted within the meaning of Section 501 (c)(3) of the Internal Revenue Code of 1986, or the corresponding section of any future Federal tax code.

Consistent with such purposes, this Trust shall not be operated for profit and no part of the earnings or revenues of this Trust shall inure to the benefit of any individual Trustee or to an entity that does not qualify under Section 501(c)(3) of the Internal Revenue Code and shall comply at all times with the provisions relating to public charities.

Article II

Powers and Duties of Trustees

New Trustees. A new Trustee shall be added only with the unanimous approval of the Trustees. The Trustees of the Trust may establish such other criteria for Trusteeship as they deem appropriate.

By-Laws. All By-Laws of the Trust shall be subject to alteration or repeal, and new By-Laws may be made, by a majority vote of the Trustees at a meeting of the Trustees called for such purpose.

Powers, Rights, and Responsibilities of Trustees. The Trustees shall have such powers and rights as are sufficient to accomplish the Trust's purposes and which are vested in the Trustees by law, the Trust Agreement, or these By-Laws. The responsibility of carrying out the charitable purposes of the Trust shall be borne by the Trustees to the full extent allowed by the funding of the Trust.

The Trustees shall have the control, management, and direction of the property and business of the Trust, including generally the power to conduct all official correspondence, sign all contracts, checks, evidences of indebtedness, or other instruments for and on behalf of the Trust, be responsible for all receipts and disbursements, pay all bills and preserve proper vouchers for such payments, receive all monies, endorse checks for collections, and deposit the corporate funds to the credit of the Trust in depositories of the Trust. Trustees shall keep an accurate account of receipts and expenditures and prepare a report of the financial status of the Trust annually.

Applications for Funding. The Trustees shall have the exclusive responsibility of applying for grants or other funding and appointing a representative to carry out the duties of the individual named to be the Point of Contact and the Authorized Organization Representative, as defined by federal regulations, for Captions for Literacy.

Meetings of the Trustees; Notice. A meeting of the Trustees may be called by any Trustee at any time, provided that there shall be at least an annual meeting. Notice of the time and place of such meeting shall be delivered to each Trustee by their preferred means of communication. The Trustees may participate in a meeting by means of a conference telephone or online conference and participation by such means shall constitute presence in person at a meeting.

Trust Actions. Except as otherwise provided by statute or these By-Laws, any Trust action authorized by the majority of Trustees at a meeting of Trustees shall be the act of the Trust. Any action that may be taken at a meeting of the Trustees may be taken without a meeting, if consents in writing setting forth the action so taken shall be signed by all the Trustees.

Compensation. The Trustees shall serve without compensation.

Limited Liability. The Trustees shall not be personally liable or responsible for the debts, liabilities, or obligations of the Trust except for such obligations as they have agreed by written instrument to assume.

Article III **Advisory Council**

To assist the management of the Trust in carrying out its charitable and educational purposes, the Trustees may appoint Members of an Advisory Council who shall have useful backgrounds, experience, or affiliations with the educational community or other pertinent organizations or fields.

Members of the Advisory Council shall serve without compensation and shall have no responsibility for the financial affairs of the Trust. They shall offer advice only; all decisions and actions of the Trust shall be made by the Trustees, for which only the Trustees shall bear liability.

Article IV **Dissolution**

Upon termination or dissolution of the Trust, any assets lawfully available for distribution shall be distributed to one or more qualifying organizations described in Section 501(c)(3) of the 1986 Internal Revenue Code (or described in any corresponding provision of any successor statute) which organization or organizations have a charitable purpose which, at least generally, includes a purpose similar to the Trust.
