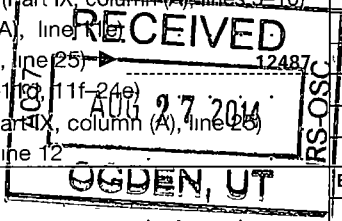

Our mission at Marinette County Elderly Services is to assist older persons in maintaining a longer, healthier, and more fulfilled life

NUTRITION: Provides hot, nutritious meals (Congregate and Home Delivered) for elderly. Promotes physical health, needed socialization, nutrition related counseling and education. Program provides information regarding additional concerns of aging. In 2013 48784 meals were served to 699 individual clients, and transportation (1094 rides) to mealsites was provided for those lacking other means of transport. Of meals served, 29335 were provided to home bound, often frail elderly unable to cook or provide own meals

4b (Code:) (Expenses \$ 226208 including grants of \$ 78770) (Revenue \$ 209733)
TRANSPORTATION Provides transportation via bus, van and private auto for medical, social, employment, personal business. Many clients are frail elderly and require private auto escort and/or wheelchair-life assistance in accessing Agency vans and buses. For 2013 the Agency provided 6871 one-way passenger trips of which 1146 were for medical appointments (202 were for frail elderly), 638 trips were for disabled riders; the remainder included rides for nutrition, employment, education and social/recreational.

LEGAL AND BENEFIT COUNSELING Provides support to individuals affected by Alzheimer's Disease and related dementia, including support groups and grants to affected individuals and caregivers. Programs include Family Caregiver Support, Medical and Prescription Drug Assistance, Community Outreach, Information and Assistance, Respite Care and related supplies funding, Energy (Heating and cooling assistance) 17 Clients received full or partial grants through Alzheimer's and/or Family Caregiver Support Programs. There were about 3000 Information/Assistance contacts. Approximately 500 Agency newsletters were distributed to clients and constituents. About 4500 contacts for National Family Caregiver Support, Alzheimer's Family Caregiver Support, Legal and Benefit Counseling, Alzheimer's and Related Dementia Program, and through Family Caregiver Support Program
