By providing training, support and a variety of community experiences, the Challenge Center helps adults with developmental disabilities to develop their individual strengths and to become intergrated more fully into their community.

Residential services provide a continuum of care options including five community based residential facilities (6-7 bed), 2 adult family homes (4 bed), 3 supervised apartments (6 bed) and an independent living support program. Each resident has their own private room and is provided appropriate care, treatment and training based on their individual needs. The 57 total beds provided 19,913 days of service in 2013. Reflecting the focus on community integration, residents participated in 11,225 community activities last year for an average of 197 activities per resident. The independent living support program serves individuals living in their own homes or preparing to transition into an independent setting. Five clients moved into a more independent living setting last year. One-to-one services that included support and training components were provided to over 30 adults with disabilities in 2013 with 5,448 hours of service

**4b** (Code: ) (Expenses \$ 1,152,338 including grants of \$ 0) (Revenue \$ 1,293,960)  
Adult day and work services provide a variety of programs appropriate to the various functional levels of the populaticn of adults with disabilities served. The sensory stimulation program, serving adults with severe to profound disabilities, provided 22 individuals with a record 21,528 hours of service. Adult day services include life skills and the seniors programs, providing daily living skills training and activities to adults with severe disabilities, served 35 individuals with 36,945 hours of service. Work services provide assessment, training and employment to adults with moderate to severe disabilities and offered 63,402 hours of service to 62 individuals. Evening weekend recreation and leisure time activities programs directly integrate consumers into their community, with 11,235 hours of service provided to over 70 participants. 94% of participants achieved at least 2/3 of their personal program goals during 2013. The community employment program provided job placement services, a community based supported employment placement, and a new assessment service contracted for youth transitioning from Superior High School in 2013. Work Incentives Benefit Analysis was added as a new service.

**4c** (Code: ) (Expenses \$ 1,120,864 including grants of \$ 0) (Revenue \$ 1,185,467)  
Enterprises were created to act as a platform for the work services program and to meet the mission in serving consumers. Marathon Industries and Bay Produce provided the environment for the employment and training of the 62 individuals enrolled in our work services program, resulting in them receiving \$126,371 in wages during 2013. Marathon Industries, begun in 1980, performs light assembly, packaging, labeling, and mailings through subcontracts with area businesses, as well as confidential paper shredding for 196 customers throughout the Twin Ports area. The paper is then baled and recycled. Bay Produce started in 1986 and operates two greenhouses using hydroponic technology to grow beefsteak tomatoes, grape tomatoes, and colorful bell peppers in a sustainable manner. Wholesale distribution totaled 367,562 pounds of produce throughout the region in 2013. Other enterprises have included space rental, professional training and contracting personal care workers to a home health agency. A total of 31,709 hours of personal care were provided during the year.
