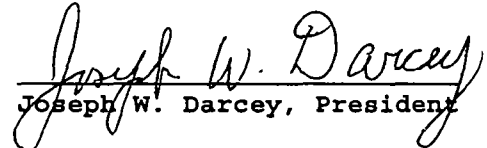
BYLAWS
